Goal

To provide the Court and Juvenile Probation Officers with an alternative sanction to hold juveniles on probation accountable for law violations and minor probation violations; while providing juveniles the opportunity to invest in their community.

Service

Some types of service include; painting, picking up trash, removal of graffiti, trail and habitat improvement, recreational improvements and assisting those that can not help themselves.

Juveniles will work with their assigned Probation Officer and the Community Service Work Officer to determine the appropriate placement(s). **All service work must be approved by the community service work officer before any service work is started.**



Outcomes

Juveniles that participate in and successfully complete this program are provided the opportunity to take accountability and responsibility for their actions while giving back to the community through service. They can build community relationships with positive examples and develop opportunities for future employment. The juveniles have the opportunity to learn to be on time, respect authority and peers, take ownership in their community, and have a sense of accomplishment of a job well done.

It is the juveniles responsibility to contact the community service officer to pay the fee and discuss a community service work placement.

The juvenile shall:

- Attend the Community Service Program Orientation with his or her parent(s). The juvenile and parent(s) shall attend the orientation to be informed of the expectations of the program and sign an agreement of understanding. The probationer shall also pay for the workman compensation insurance fee and receive a time sheet at that time.

All payments **must** be made individually with the **exact amount**. The workman compensation fee is \$.60/ hr. and must be paid in full.

- Work with his or her assigned Probation Officer and the Community Service Work Officer to determine the appropriate placement(s). **All service work must be approved by the community service work officer before any service work is started.**
- Return the completed time sheet to his or her assigned probation officer. **All information must be filled out completely and accurately to receive credit for the hours. If the hours are falsified in any way, a probation violation may be filed.** Parents, grandparents, siblings, family friends, or neighbors are **not** to sign timesheets.

Expectations of Conduct

Be on time and have transportation arranged for the assigned placement.
Be prepared with food and drink as needed.
Be dressed appropriately for the project and the weather (**pants, t-shirt, and closed toe shoes are required.**)
Be accountable; call the assigned placement to confirm the project schedule. Call the assigned placement 24hrs in advance if not able to attend. Be respectful to authority and peers. Follow the rules of the assigned placement.
Be on task and willing to take direction.
Be responsible, bring your time sheet to each project to receive credit for the hours worked.

No use of foul or disrespectful language
No use of electronic devices at any time. The Juvenile Probation Department does not accept liability for any loss, damage or theft of personal property.
No use of tobacco
No horseplay
No friends may visit the worksite
No violating any terms of probation
No violating the law

If the juvenile fails to comply with the expectations of conduct he or she may:

Receive a warning
Be instructed to leave the project
Not receive credit for hours worked

Probation will be immediately notified.

****Non compliance will be reported to the juveniles' probation officer and may result in a probation violation.** The community service officer and the juveniles' probation officer will determine whether the juvenile is appropriate to continue with community service.
