**Re: *FY22 Pickles Butte Sanitary Landfill Geotechnical Expansion Boring Project***

Dear Licensed Public Works Contractor:

We wish to update you regarding Canyon County's FY22 Pickles Butte Sanitary Landfill Geotechnical Expansion Boring Project Solicitation of Bids sent to you on September 10, 2021.

On September 15, 2021, Trent Castner informed the Board of County Commissioners that Cascade Drilling would not be submitting a bid for this project. No objections to the specification or bid procedures were received, and one bid was timely received from Holt Services Inc. on October 1, 2021.

Because only one bid was received, the Board has determined that it is empowered by Idaho Code § 67-2805(1)(e) to acquire this work in any manner it deems best from a qualified public works contractor quoting the lowest price; in this case, the bid of \$145,809.00 submitted by Holt Services Inc., a qualified public works contractor. The Board further believes that additional competitive solicitation is impractical, disadvantageous, or unreasonable in light of the process just concluded (see I.C. § 67-2808(2)(viii)). In light of these circumstances, the Board hereby gives notice of its intent to consider contracting with Holt Services Inc. for this project at its offered cost as follows:

If anyone objects to this conclusion or process, please provide your objections to the Board no later than 5:00 p.m. on October 28, 2021, setting forth the basis of your objection and the further steps you believe the Board should take, and the Board will consider such objections.


Holt Services Project Manager, Jeff Townsend, will soon receive a letter from the County's attorney to discuss coordination details as necessary.
