Questions:

1. Written questions:

Kent Smart - Tek84

- Q.1. What is the narrowest door width and height on the pathway from the sally port to the end location? Measured to the nearest 1/4"
- A.1. All man door openings are 34½ inches wide by 83¼ inches tall.
- Q.2. Is there a height difference between the sally port and the door leading into the hallway?
- A.2. Yes, the ceiling height in the sally port is 117 inches and the ceiling height in the hallway is 107 inches. The sally port door is 96 inches.
- O.3. What is the width of the hallway?
- A.3. The width of the hallway is $61\frac{1}{2}$ inches.

Jack McLaughlin with Command Sourcing:

- Q.1. What are the actual dimension of the room? Including actual height of ceiling.
- A.1. The room is 120½ inches wide, 152½ inches long, and 107½ inches to the ceiling but there is a light that hangs down 5 inches.
- Q.2. What is the width of each door on the path to the body scanner from the sally port?
- A.2. All door openings are 34½ inches wide by 83¼ inches tall.

- Q.3. Will the wall at the front of the room be removed?
- A.3. Our Maintenance Department is looking into the removal of the wall and at this time it appears will be able to remove the wall.
- Q.4. Is there a need for a thermo imaging device to measure body temperature in addition to the body scanner?
- A.4. We do not have a need for thermo imaging.
- Q.5. Section 2, D requests a copy of the "contractors financial report". We are a privately held company and so we have no annual report or CPA audited financials. We would like to meet this requirement but cannot provide these documents. We could provide a copy of: our latest taxes, P&L and/or balance sheet or request this information from the manufacturer of the product we are representing. Would these solutions satisfy this request or can you provide alternative proof to meet this requirement?
- A.5. Your solutions will satisfy the request.

2. Questions from Pre-Proposal Conference:

Questions were asked by Kent Smart with Tek84 and Jack McLaughlin with Command Sourcing.

- Q.1. Can we see the path of how the machine would be brought in?
- A.1. Deliveries can come from either side of the sally port.
- Q.2. Can we take picture?
- A.2. Yes, since it is not a secure area where inmates are.
- Q.3. What or how many electrical outlets are in the room?
- A.3. There are two power outlets that have a power strip that will be changed to a normal electrical outlet.
- Q.4. What is the size of the room?
- A.4 It is about 10X12 feet.

Captain Patchett also showed a wall referred to by Commissioner Van Beek that may need to be removed.

- Q.5. This will then turn the room into an open room?
- A.5. Yes.
- Q.6. Is there storage for the machine to be stored before installation?
- A.6. Yes, there is some room in the sally port.
