DEFINITION: AGRICULTURAL BUILDING (06-01-07) A structure designed and constructed to house farm implements, hay, grain, poultry, livestock or other horticultural products on Agriculturally zoned land which Agriculturally zoned land shall consist of at least a single parcel of land of more than five (5) acres in size, exclusive of any public right-of-way. This structure shall not be a place of human habitation or a place of employment where agricultural products are processed, treated, packaged or sold, not for working on equipment, nor shall it be a place used by the public. Structure can have electrical and plumbing (sinks ONLY, no bathrooms). By signing this certificate, I, the owner, represent that this structure will be used only as an Agricultural Building as defined above. I understand that any future use of the structure not related to agriculture is a violation of the Canyon County Building Code Ordinance and code enforcement action will result. I also agree to additional future inspections to verify that the structure is only used as defined and permitted.
