Canyon County – Road Name Change, RD2023-0015

Findings of Fact, Conclusions of Law, Conditions of Approval and Order

Pursuant to CCZO §06-05-13.1 & §06-05-13.2 “There shall be no duplication of street names by sound or spelling within Canyon County including within the incorporated areas” and “Differentiation of street names shall not be by the addition of a street designation such as road, street, avenue, lane, etc.” Snow Goose Ct is a duplicate road name, as Snowgoose St exists within the city of Nampa and has existed prior to Snow Goose Ct’s approval in 2006.

Findings

1. The proposed road name change request is compliant with Canyon County Addressing Ordinance.
2. Canyon County staff attempted to work with affected property owners to receive a consensus on a new road change.
3. Property owners having frontage on the affected street (s) were officially notified by mail at least thirty (30) days prior to the hearing as required by Canyon County Addressing Ordinance §06-05-13 (11).

Conclusions of Law

For case file RD2023-0015 the Board concludes the following regarding a request for a Road Name Change:

1. Are the proposed changes in compliance with Canyon County Addressing Ordinance requirements?

Yes, the proposed changes are in compliance with Canyon County Addressing Ordinance requirements, §06-05-13 (2). The proposed road names are not a duplication of any street name within Canyon County.

Conditions of Approval

1. Property Owners will be responsible for the installation and maintenance of the road sign required by Canyon County Addressing Ordinance §06-05-15 (2) B.

The private road is not within a platted subdivision. The County will alert agencies of the private road name change and notice all property owners of their new address and the next steps required of them.

Order




Based upon the Findings of Fact, Conclusions of Law and Conditions of Approval contained herein the Board of County Commissioners **approve** Case # RD2023-0015 a request to change the road name for approximately 400 feet of Snow Goose Ct, which runs south/north (north of Lower Pleasant Ridge Rd).

The south/north portion of Snow Goose Ct. that terminates at Lower Pleasant Ridge Rd will be renamed to either

- 1) A name submitted by property owners to Development Services Department within 90 days of December 21, 2023 (March 20, 2024) that complies with Canyon County Ordinance §06-05-13; or if no name is submitted then
- 2) White Snow Goose Ln will be the new private road name (Approximately 400 ft.).
