# **Mitigation Updates**

- o Section 106 Report for WIF Grant Project
  - Nicki Schwend provided an update on the WIF Grant Project. Report has been submitted to US Army Corps of Engineers. Shoshone-Paiute Tribe has provided comment.
- o Karcher Communication Tower
  - Through ongoing negotiation, the staff have come to a tentative agreement with the company installing the communication tower. As mitigation for

installing the tower by the NRHP eligible barn, they will give the county \$20,000 to hire a local firm to complete historical agricultural resources survey in the county. Draft of the Memorandum of Agreement is circulating through all parties.

- o Caldwell Subdivision
  - Conversations on mitigation is ongoing. Last meeting time was set aside for discussion with the Tribes involved, and next meeting has been canceled for Thanksgiving.
- Project Spud
  - A new mitigation project has come to the attention of the staff. Nicki and Chelsee quickly summarized the distribution center and their application to construct in Nampa. Section 106 has been triggered, and discussions surrounding the application and impact on NRHP resources must follow. First meeting to discuss this will be next Friday.

## **New Business**

- o ACTION: Snake River Canyon Preservation Assessment survey review
  - Commission reviewed the draft of the survey from Historical Research Associates Inc. (HRA) and discussed necessary updates. Nicki and Chelsee previously did some editing, and went over those changes with the Commission. Staff is going to prepare a website, to link with the survey and provide more information to property owners. Soon staff will be meeting with HRA to talk about next steps. Commission decided that no formal action was necessary for this discussion.
- o ACTION: December Meeting
  - Commission discussed the necessity of a meeting in December. Vicki motioned to cancel the December meeting. George seconded. HPC will reconvene in January.
