- Bruce reviewed the one-page document he created as a roadmap for what applicants to use. Bruce gave this document to the Parma Library and the American Legion Post. Bruce reviewed each section of the document and provided an in-depth summary on what each part of the survey would require.
- Bruce spoke to Dan at SHPO who recommended architects to him. Bruce talked to them about getting involved in various projects, Steve Trout was willing to get involved. Steve went to Parma City Council meeting to testify on behalf of Sharlene at the Public Library to gain support for application.
- Bruce proposed incorporating this into the application material. Nicki Schwend and Chelsee agreed that it would be good to incorporate this into the grant application

 - Bruce said that it may be difficult to simplify, as the specifics in the document speak to the specific work that needs to be done.
