SUMMARY:

The applicants, Charles and Linda Bowery, request to amend the official zoning map to conditionally rezone Parcel R24645, approximately 1.05 acres, from an "R-R" (Rural Residential) zone to a C-1 (Neighborhood Commercial) zone. The request includes a development agreement limiting the commercial use to a contractor shop, a staging area, and a caretaker unit.

The Planning & Zoning Commission heard the case at a public hearing held on March 6, 2025. After deliberation, the Planning & Zoning Commission recommended denial due to the request not being generally consistent with the 2030 Comprehensive Plan and the request not being more compatible with the surrounding land uses (Exhibits 1 and 2).

The Staff report packet dated March 6, 2025, and all supporting material are contained in Exhibit 3. Additional supporting documentation may be found in Exhibit 4. Included is a draft of Findings of fact, Conclusions of law, and Order based on the Planning & Zoning Commission's recommendation in Exhibit 5.

FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

In the matter of the application of: **Bowery – CR2023-0005**

The Canyon County Planning and Zoning Commission considers the following:

- Conditional Rezone of Parcel R24645, approximately 1.05 acres, from an "R-R" (Rural Residential) zone to a C-1 (Neighborhood Commercial) zone.
- 2) Development agreement to limit commercial use to a contractor shop, staging area, and caretaker unit.
- Location: 6019 Stamm Lane, Nampa (Parcel R24645), also referenced as a portion of the SE¼ of Section 18, T3N, R1W, Canyon County, Idaho.

Summary of the Record

- 1. The record is comprised of the following:
 - A. The record includes all testimony, the staff report, exhibits, and documents in Case File CR2023-0005.

Applicable Law

- The following laws and ordinances apply to this decision: Canyon County Code of Ordinances (CCCO) §01-17 (Land Use/Land Division Hearing Procedures), CCCO§07-05 (Notice, Hearing and Appeal Procedures), CCCO§07-06-01 (Initiation of Proceedings), CCCO§07-06-07 (Conditional Rezones), CCCO §07-10-27 (Land Use Regulations (Matrix)), Idaho Code §67-6511 (Zoning Map Amendments and Procedures), and CCCO §09-11-25(Area of City Impact Agreement).
 - a. Notice of the public hearing was provided per CCCO §07-05-01 and Idaho Code §67-6509.
 - b. The presiding party may establish conditions, stipulations, restrictions, or limitations which restrict and limit the use of the rezoned property to less than the full use allowed under the requested zone, and which impose specific property improvement and maintenance requirements upon the requested land use. Such conditions, stipulations, restrictions, or limitations may be imposed to promote the public health, safety, and welfare, or to reduce any potential damage, hazard, nuisance, or other detriment to persons or property in the vicinity to make the land use more compatible with neighboring land uses. *See* CCCO §07-06-07(1).
 - c. All conditional rezones for land use shall commence within two (2) years of the approval of the board. If the conditional rezone has not commenced within the stated time requirement, the application for a conditional rezone shall lapse and become void. *See* CCCO §07-05-01
- 2. The commission has the authority to exercise powers granted to it by the Idaho Local Land Use and Planning Act ("LLUPA") and can establish its own ordinances regarding land use, including subdivision permits. *See* I.C. §67-6504, §67-6511.
- 3. The commission shall have those powers and perform those duties assigned by the board that are provided for in the local land use planning act, Idaho Code, title 67, chapter 65, and county ordinances. CCCO §07-03-01, 07-06-05.
- 4. The burden of persuasion is upon the applicant to prove that all criteria are satisfied. CCCO §07-05-03.
- 5. Idaho Code §67-6535(2) requires the following: The approval or denial of any application required or authorized pursuant to this chapter shall be in writing and accompanied by a reasoned statement that explains the criteria and standards considered relevant, states the relevant contested facts relied upon, and explains the rationale for the decision based on the applicable provisions of the comprehensive plan, relevant ordinance and statutory provisions, pertinent constitutional principles and factual information contained in the record. The

County's hearing procedures adopted per Idaho Code §67-6534 require that final decisions be in the form of written findings, conclusions, and orders. CCCO 07-05-03(1)(I).

The application, CR2023-0005, was presented at a public hearing before the Canyon County Planning and Zoning Commission on March 6, 2025. Having considered all the written and documentary evidence, the record, the staff report, oral testimony, and other evidence provided, including the conditions of approval and project plans, the Planning and Zoning Commission decides as follows:

CONDITIONAL REZONE CRITERIA – CCCO §07-06-07(6)

1. Is the proposed conditional rezone generally consistent with the comprehensive plan?

Conclusion: The proposed conditional rezone change is not generally consistent with the Comprehensive Plan.

- Findings: (1) The 2030 Canyon County Comprehensive Plan designates the parcel and area as "residential" (Exhibit B.2c of the staff report). The residential designation is described as follows: "The residential designation is for residential development. Residential development should promote compatibility with the existing agricultural activity" (page 25, 2030 Comp. Plan).
 - (2) The parcel and surrounding area are located in the Nampa Area of City Impact. Nampa designates the future land use of the parcel and area as "Low-Density Residential" (Exhibit B.2d of the staff report). However, at the time the applicant applied, Nampa's 2040 Comprehensive Plan designated the area as commercial (Exhibit A.2 of the staff report).
 - (3) The requested commercial zone and uses do not align with the following goals and policies of the 2030 Comprehensive Plan:
 - a. <u>Population G2.02.00</u>: "Promote housing, business, and service types needed to meet the demand of the future and existing population."
 - i. The Traffic Analysis Zone (TAZ) forecasts the area for residential household growth in the area between 2024 and 2050 (Exhibit B.2h of the staff report). The TAZ is used by COMPASS (Community Planning Association) as a tool to plan funding for future transportation needs.
 - b. <u>Economic Development G3.05.00</u>: "Support a diverse economy in Canyon County and recognize that residential, commercial, and industrial uses are necessary components of overall economic stability."
 - i. The County and City of Nampa both identify the area for residential growth, not commercial growth (Exhibits B.2c & d of the staff report).
 - c. <u>Land Use & Community Design P4.03.01</u>: Designate areas that may be appropriate for industrial, commercial, and residential land uses while protecting and conserving farmland and natural resources.
 - i. The County and City of Nampa both identify the area for residential growth, not commercial growth (Exhibits B.2c & d of the staff report).
 - d. <u>Land Use & Community Design P4.03.02</u>: Encourage the development of individual parcels and subdivisions that do not fragment existing land use patterns.
 - i. The County and City of Nampa both identify the area for residential growth, not commercial growth (Exhibits B.2c & d of the staff report).
 - e. Land Use & Community Design P4.04.02: Align planning efforts in areas of city impact.
 - The parcel and surrounding area are located in the Nampa Area of City Impact. Nampa designates the future land use of the parcel and area as "Low-Density Residential" (Exhibit B.2d of the staff report). The City of Nampa opposes the request (Exhibit D.1 of the staff report).
 - (4) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.

(5) Evidence includes subsequent findings and evidence found in criterion 2 and 3.

- 2. When considering the surrounding land uses, is the proposed conditional rezone more appropriate than the current zoning designation?
 - **Conclusion:** In consideration of the surrounding land uses, the proposed conditional rezone to a "CR-C-1" (Conditional Rezone Neighborhood Commercial) is <u>not</u> more appropriate than the current zoning designation of "R-R" (Rural Residential).
 - Findings: (1) Existing/Current Conditions
 - A. The parcel and surrounding area are zoned "R-R" (Rural Residential, two-acre average minimum lot size, Exhibit B.2e of the staff report). According to CCCO §07-10-25(2), "the purpose of the R-R (Rural Residential) Zone is to encourage and guide growth in areas where a rural lifestyle may be determined to be suitable." The zoning is commensurate with the 2030 Canyon County Comprehensive Plan which designates the parcel and area as "residential" (Exhibit B.2c of the staff report).
 - B. The parcel and area are in the Nampa Area of City Impact. The city designates the future land use of the area as "low-density residential" (Exhibit B.2d & D.1 of the staff report). City jurisdiction is located approximately 2,000 feet west of the subject parcel (Exhibit B.2d of the staff report).
 - C. The area consists of parcels with an average lot size of 1.78 acres and a median of 1.05 acres. There are 46 residential subdivisions within a one-mile radius consisting of 844 lots and an average lot size of 1.38 acres (Exhibit B.2g of the staff report). 13 of the 46 subdivisions are located in the City of Nampa.
 - D. The following land use decisions were found in the vicinity between 2016 and 2024 demonstrating the support of residential growth in the area:
 - <u>PH2016-10 Parcel R30461</u>: Rezone from "R-R" to "R-1" (Single Family Residential, one-acre average minimum lot sizes, 12,000 square foot lot sizes if connected to city water/sewer).
 - (2) <u>RZ2022-0008 Parcel R30591</u>: Rezone from "A" to a "CR-R-1".
 - (3) <u>RZ2018-0027 Parcel R247916010</u>: Rezone from "R-R" to "R-1".
 - (4) <u>PH2018-64 Parcel R27925</u>: Rezone from "R-R" to "R-1".
 - (2) <u>Request</u>
 - A. The applicants request a "C-1" (Neighborhood Commercial) zone. Pursuant to CCCO §07-10-25(5), "the purpose of the C-1 (Neighborhood Commercial) Zone is to provide for local commercial service needs and to restrict incompatible uses."
 - B. There are no commercial zones or similar land use decisions within the vicinity of the subject parcel (Exhibit B.2f of the staff report). The applicant states the area has similar businesses within the vicinity (Exhibit A.2 of the staff report). Businesses found within the immediate area (Nick's Custom Designs, Gem Swim, Holistic Alchemist Wellness and Bodywork, and Zeguro Tax and Accounting, Exhibit B.6 of the staff report) are allowed in the "R-R" zone subject to meeting home business or home occupation requirements per CCCO Section 07-02-03, 07-10-27, and 07-14-11 & 13 (Exhibit B.5 of the staff report). Based on the site visit (Exhibit C of the staff report), staff did not find any contractor shops/staging area uses in the immediate area.
 - C. The nearest commercial use and designation is the Nampa Gateway Center within Nampa city jurisdiction, approximately 2,500 feet west of the subject parcel. The City of Nampa opposes the request and requested uses due to the city's future land use designation supporting low-density residential zones and that the uses proposed are not supported in a low-density residential zone (Exhibit D.1 of the staff report).

(5) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.

3. Is the proposed conditional rezone compatible with surrounding land uses?

- **Conclusion:** The proposed conditional rezone to "CR-C-1" (Conditional Rezone Neighborhood Commercial) is <u>not</u> compatible with surrounding land uses.
- Findings: (1) Pursuant to CCCO § 07-02-03: "Land uses are compatible if: a) they do not directly or indirectly interfere or conflict with or negatively impact one another and b) they do not exclude or diminish one another's use of public and private services."
 - A. The parcel and surrounding area are zoned "R-R" (Rural Residential, two-acre average minimum lot size, Exhibit B.2e of the staff report). The parcel and area are in the Nampa Area of City Impact. The city designates the future land use of the area as "low-density residential" (Exhibit D.1 & B.2d of the staff report).
 - B. The area consists of parcels with an average lot size of 1.78 acres and a median of 1.05 acres. There are 46 residential subdivisions within a one-mile radius consisting of 844 lots and an average lot size of 1.38 acres (Exhibit B.2g of the staff report). 13 of the 46 subdivisions are located in the City of Nampa.
 - C. The following land use decisions were found in the vicinity between 2016 and 2024 demonstrating the support of residential growth in the area:
 - <u>PH2016-10 Parcel R30461</u>: Rezone from "R-R" to "R-1" (Single Family Residential, one-acre average minimum lot sizes, 12,000 square foot lot sizes if connected to city water/sewer).
 - <u>RZ2022-0008 Parcel R30591</u>: Rezone from "A" to a "CR-R-1".
 - <u>RZ2018-0027 Parcel R247916010</u>: Rezone from "R-R" to "R-1".
 - <u>PH2018-64 Parcel R27925</u>: Rezone from "R-R" to "R-1".
 - D. There are no commercial zones or similar land use decisions within the vicinity of the subject parcel except Nampa Gateway Center approximately 2,500 feet west of the parcel in Nampa city limits and some home business and home occupation uses that are allowed in an "R-R" Zone (Exhibits B.2f & B.6 of the staff report).
 - (2) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.

4. Will the proposed conditional rezone negatively affect the character of the area? What measures will be implemented to mitigate impacts?

- **Conclusion:** The proposed conditional rezone will negatively affect the character of the area. However, the applicants propose conditions such as hours of operation and site-obscuring fencing to minimize the impacts on the surrounding residential uses.
- Findings: (1) The area consists predominantly of residential uses. Staging areas, contractor shops, and caretaker residences are prohibited in all residential zoning districts (Exhibit B.5 of the staff report). In the "A" (Agricultural) zone, the next closest designation (Exhibit B.2e of the staff report), the requested uses require a conditional use permit due to the uses possessing "characteristics which require review and appraisal by the commission to determine whether or not the use would cause any damage, hazard, nuisance or other detriments to persons or property in the vicinity" (CCCO §07-07-01: Conditional Use Permit Purpose).
 - (2) There are no commercial zones or similar approved uses within the vicinity of the subject parcel (Exhibit B.2 of the staff report).

- (3) The applicants propose conditions such as hours of operation and site-obscuring fencing to minimize the impacts on the surrounding residential uses. The letter of intent (Exhibit A.2 of the staff report) states the property is used for their business, CBI Insulation, which includes the parking of six box trucks and employee parking for nine employees (Exhibit A.4 of the staff report). The parking area is enclosed by vinyl fencing. Business hours are approximately 7 am to 5 pm (box truck parking 5 pm to 7 am). The existing detached garage has a restroom that may be for employees.
- (4) Notice of the public hearing was provided per CCCO §07-05-01. Affected agencies were noticed on October 9, 2024 and January 29, 2025. A newspaper notice was published on January 30, 2025. Property owners within 1,000' were notified by mail on January 30, 2025. The property was posted on February 5, 2025.
 - a. No public comments.
 - b. A comment was received from the City of Nampa's Planning and Zoning Division on October 9, 2024 (Exhibit D.1 of the staff report). The city opposes the request due to the proposed commercial zone and requested uses not being compatible with the Low-Density Residential designation.
- (5) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.

5. Will adequate facilities and services including sewer, water, drainage, irrigation, and utilities be provided to accommodate proposed conditional rezone?

- **Conclusion:** The project will have adequate sewer, water, drainage, irrigation, and utilities to accommodate the proposed conditional rezone.
- Findings: (1) Sewer: The existing dwelling is served by a septic system. The staging area/contractor shop uses requested as part of the conditional rezone application do not require a new septic system (Exhibit A.4). The existing garage restroom may be used for employees (Exhibit A.2 of the staff report). Southwest District Health requests the applicant meet regarding the request (Exhibit D.4 of the staff report). No information was submitted demonstrating a meeting was completed.
 - (2) <u>Water</u>: The existing dwelling is served by a domestic well. The staging area/contractor shop uses requested as part of the conditional rezone application, does not require a new well. The existing well can be used for fire suppression (Exhibit A.4 of the staff report).
 - (3) <u>Drainage</u>: It appears that drainage is maintained on-site (Exhibit B.2a and C of the staff report). Nampa-Meridian Irrigation District requests all drainage be maintained on-site (Exhibit D.2 of the staff report).
 - (4) <u>Irrigation</u>: The applicant does not say if they have irrigation water rights or if the property is irrigated by a well. The letter from the Nampa-Meridian Irrigation District does not indicate if the property has water rights from the district (Exhibit D.2 of the staff report). The property only has approximately 0.26 acres of grass/tree areas. The rest of the property is gravel (Exhibit B.2a). Therefore, the property could be irrigated by domestic well per Idaho Code Section 42-111.
 - (5) Utility: The property appears to have utilities established for the existing dwelling (Exhibit C of the staff report).
 - (6) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.
- 6. Does the proposed conditional rezone require public street improvements in order to provide adequate access to and from the subject property to minimize undue interference with existing or future traffic patterns? What measures have been taken to mitigate traffic impacts?

- **Conclusion:** The request is not anticipated to create undue interference with existing or future traffic patterns.
- Findings: (1) The subject property has access to Stamm Lane, a rural local roadway. Nampa Highway District #1 does not state any concerns regarding the request and future traffic subject to meeting access requirements (Exhibit D.6 of the staff report).
 - (2) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.
- 7. Does legal access to the subject property for the conditional rezone exist or will it exist at time of development?
 - Conclusion: The subject property does have legal access to the existing residential development.
 - Findings: (1) The subject property has access to Stamm Lane, a rural local roadway. Nampa Highway District #1 requires commercial accesses to be a paved apron installed per ACCHD Standard Drawing #ACCHD-106. The applicants will need to upgrade the existing residential access to a paved apron to meet Highway District Commercial Access standards (Exhibit D.6 of the staff report).
 - (2) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.
- 8. Will the proposed conditional rezone amendment impact essential public services and facilities, such as schools, police, fire, and emergency medical services? What measures will be implemented to mitigate impacts?
 - **Conclusion:** The proposed uses are not anticipated to impact essential public services and facilities including, but not limited to schools, police, fire, and emergency medical services.
 - **Findings:** (1) Schools: The property is served by the Nampa School District (Exhibit B.1 of the staff report). The request with limited uses is not anticipated to impact the school district. No comment was received from the district.
 - (2) Police: The property is served by the Canyon County Sheriff's Office. No comment or concerns were received from the Sherriff's Office.
 - (3) Fire Protection & Emergency Medical Services: The property is served by Nampa Fire District and Canyon County Paramedics/EMT. No comments or concerns were received from Canyon County Paramedics/EMT. Nampa Fire District is not opposed to the request (Exhibit D.5 of the staff report). The request does not negatively impact response time. The property is 1.6 miles from Nampa Fire Station 5 with a response time of approximately four minutes.
 - (4) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.

Canyon County Code of Ordinances §09-11-25 AREA OF CITY IMPACT AGREEMENT ORDINANCE

- **Conclusion:** The property is located within the Nampa Area of City Impact. A notice was sent to the City of Nampa per Canyon County Code of Ordinances (CCCO) §09-11-25 (09-11-17(3)).
- Findings: (1) The City of Nampa was noticed on October 9, 2024, and January 29, 2025. A comment was received from the City of Nampa's Planning and Zoning Division on October 9, 2024 (Exhibit D.1 of the staff report).
 - (2) The City of Nampa's comprehensive plan designates the parcel and surrounding area as "Low-Density Residential" on the future land use map (Exhibit D.1 of the staff report). When considering the City of Nampa's future land use map, the request is not compatible. A comment was received from the City of Nampa's Planning and Zoning Division on October 9, 2024 (Exhibit D.1 of the staff report). The city opposes the request due to the proposed

commercial zone and requested uses not being compatible with the Low-Density Residential designation.

(3) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.

Order

Based upon the Findings of Fact, Conclusions of Law and Order contained herein, the Planning and Zoning Commission recommends **denial** of Case # CR2023-0005, a conditional rezone of Parcel R24645 from an "R-R" (Rural Residential) zone to a C-1 (Neighborhood Commercial) zone.

Chairman Sturgill called the meeting to order at 6:30 p.m.

Commissioner Nevill read the testimony guidelines and proceeded to the first business item on the agenda.

CONSENT AGENDA

- A. Case No. CU2023-0024 Erlebach Properties, L.P.: Approve revised FCO's
- B. Case No. CU2024-0008 Ransom: Approve revised FCO's
- C. Case No. RZ2023-0003 Jaggers: Approve revised FCO's

Motion: Commissioner Sheets moved to approve the Consent Agenda, seconded by Commissioner Mathews. Voice vote, motion carried.

Item 2A:

Case No. RZ2022-0016 – Goodwin: The applicant, Gary Goodwin, requests a conditional rezone of Parcel R31008 from an "A" (Agricultural) zone to a "CR-M-1" (Conditional Rezone - Light Industrial) zone. The request includes a development agreement restricting uses to an RV storage facility, outdoor equipment rental, and caretaker residence. The subject property, 1.31 acres, is located at 16982 Madison Ave.

Chairman Sturgill called the applicant to testify.

Gary Goodwin – (Applicant) IN FAVOR – 16982 Madison Rd., Nampa, ID 83687

Mr. Goodwin stated that at the last meeting it was discussed and agreed upon that they submit a conditional rezone plan so they could move forward and they have done that. They have followed all of the expectations of the Commission as to what needed to be done. The only area that there seems to be a dispute is in regard to floodplain. They dispute that. They have sent out a notice to everyone that has an RV on their property that should there be a flood they would have to move their RV until the danger had ceased. All parties agreed. There is a fence around the property and they will keep it good repair. Mr. Goodwin provided pictures for the record in regard to buffering. Lights will be downturned. There are two entrances onto the property. There will be 46 spots.

Commissioner Sheets asked if Mr. Goodwin had the opportunity to review the staff report. He indicated that he had and that he agreed with the four (4) conditions.

Planner Dan Lister reviewed the Staff Report for the record.

Commissioner Nevill asked Planner Lister about the number of spots and referenced condition 2A. Commissioner Nevill asked if the change from 40 - 46 would impact any of the staff analysis. Planner Lister stated it would not.

Chairman Sturgill affirmed the witnesses to testify.

Testimony:

Debra Goodwin – IN FAVOR – 16982 Madison Rd., Nampa, ID 83687

Ms. Goodwin read an email from the City of Nampa for the record.

Planner Dan Lister stated that the property is located in a floodplain and mapped by FEMA. The source of the flooding is Mason Creek. Any owner can submit to FEMA updated studies / remedies to get a letter of map revision.

Commissioner Matthews asked about a utility going through the culvert and whether or not that impacted the floodplain. Ms. Goodwin stated not that she is aware of.

MOTION: Commissioner Sheets moved to close public testimony on Case No. RZ2022-0016, seconded by Commissioner Mathews. Voice vote, motion carried.

Deliberation:

Commissioner Sheets stated he was in agreement with the staff report and conditions of approval with one modification; condition 2A should reflect 46 storage spaces.

MOTION: Commissioner Sheets moved to **recommend approval** of Case No. RZ2022-0016 to the Board of County Commissioners, with the previously discussed modification to condition 2A to reflect 46 storage spaces. Seconded by Commissioner Mathews.

Discussion on the Motion:

None.

Roll call vote: 4 in favor, 0 opposed, motion passed.

Item 2B:

Case No. CR2023-0005 – Bowery: The applicant, Linda and Charles Bowery, request an amendment to the official zoning map to conditionally rezone Parcel R24645, approximately 1.05 from, from an "R-R" (Rural Residential) zone to a C-1 (Neighborhood Commercial) zone. The request includes a development agreement limiting the commercial use to a contractor shop, staging area, and caretaker unit. The property is located at 6019 Stamm Lane, Nampa.

Chairman Sturgill called the applicant to testify.

Linda Bowery – (Applicant) IN FAVOR – 6019 Stamm Ln., Nampa, ID 83687

Ms. Bowery stated the property was purchased four years ago. There are five company trucks and currently there are five employees. In 2023 they received a violation notice. The previous owners of the property had a business. It was listed as a business property. One entrance was grandfathered in as a business access. The employees come to the site, pick up a truck, and go to the job site(s). There is a

three-bay shop on the property used for tools/equipment and a small meeting place to warm up after a long day. They just want to be able to keep parking their trucks on the property. There are numerous businesses in the area.

Commissioner Nevill asked if the conditions had been reviewed. Ms. Bowery said she hadn't had a chance to review them all.

Planner Dan Lister reviewed the Staff Report for the record.

Commissioner Nevill asked about the businesses that are in the area. Planner Lister stated home businesses/occupations don't change the essential character of the residential use but are limited to size/use. Beyond that a CUP or a rezone would be required.

Chairman Sturgill affirmed the witnesses to testify.

Testimony:

Charles Bowery – IN FAVOR – 6019 Stamm Ln. Nampa, ID 83687

Mr. Bowery asked that the Commission consider approval of his request. They want to do everything right.

Reuben DeKastle – IN FAVOR – 5825 Stamm Ln. Nampa, ID 83687

Mr. DeKastle is a neighbor to the Bowerys. The Bowery's business is quiet and they do not impact them at all. When the Bowerys moved in they installed a fence and have completed many upgrades. They are good neighbors. He prefers this type of use than high density housing. He is in support of the Bowery's application.

Commissioner Nevill asked if the proposed use is compatible with surrounding land uses. Mr. DeKastle stated that the use is compatible. The property has been used for business purposes for years prior to the Bowerys so it would not be something new.

Linda Bowery – (Applicant)-REBUTTAL– 6019 Stamm Ln., Nampa, ID 83687

Ms. Bowery stated that she reviewed the conditions and they don't have any issues with them.

MOTION: Commissioner Sheets moved to close public testimony on Case No. CR2023-0005, seconded by Commissioner Matthews. Voice vote, motion carried.

Deliberation:

Commissioner Sheets stated the request is to rezone which is permanent. This would be an island of commercial in a "sea" of residential.

Commissioner Nevill concurred with Commissioner Sheets' analysis. If the rezone were to be approved and the property owners sold their property in the future, there are many other uses in the commercial zone that may not be compatible with the area.

Commissioner Matthews asked if it was possible to have a conditional use permit for this use in the RR zone. Planner Lister replied no, it would require a text amendment to change the ordinance to allow the use in a Rural Residential zone.

Planner Johnson reiterated that this rezone is a conditional rezone and uses could be limited.

Planner Lister read the recommended conditions of approval for the P&Z Commission's consideration, including the uses that would be allowed. Once the home is no longer a "caretaker's residence" the agreement would have to be terminated. Discussion ensued regarding enforcement of conditions.

MOTION: Commissioner Nevill moved to **recommend denial and accept staff's findings** for Case No. CR2023-0005. Seconded by Commissioner Sheets.

Discussion on the Motion: None.

Roll call vote: 3 in favor, 1 opposed, motion passed.

Item 2C:

Case No. CU2022-0008 – Tellez: Ivan Tellez is requesting a Conditional Use Permit to utilize two contiguous parcels totaling 24.31 acres to build and operate a commercial arena and race track. The applicant proposes to conduct two events per month April through November. The proposed event hours will be from 11:00 a.m. to 8:00 p.m. There will be amplified sound for announcers and music. The applicant proposes capacity for a maximum 150 vehicles accommodating 500 people at an event. They propose to sell food and alcohol (beer) onsite. Restroom facilities will be provided via portable units for the activities. The subject property is located at 27410 Peckham Road, Wilder ID, also referenced as Parcel R36854010A and R36854010.

Chairman Sturgill called the applicant to testify.

Ivan Tellez – (Applicant) IN FAVOR – 27410 Peckham Rd., Wilder, ID 83676

Mr. Tellez spoke through an interpreter. Mr. Tellez stated that the purpose of the construction is to provide training for race horses. The closest track is 3 hours away in Jerome, ID. Mr. Tellez's traffic study confirmed that traffic will not be an issue for construction. The track would be good for Wilder and the County. Many individuals have provided letters in support of the track construction.

Commissioner Nevill asked about the use and whether or not there would be events on site. Mr. Tellez stated that the purpose of the events are to raise funds for the construction. It is good training for the horses to see people in the audience so when they race they are not scared. Commissioner Nevill asked if the letters of support were submitted for the record. Mr. Tellez stated he brought them tonight. Discussion ensued regarding the number of letters.

Commissioner Matthews asked where the racetrack was located. Planner Barron indicated the exhibit was located in the staff report. Commissioner Matthews asked if stands would be built. Mr. Tellez replied no. Commissioner Matthews asked where parking would be located as well as access. Mr. Tellez referenced the map that was submitted which depicts where the parking is located.

Commissioner Sheets asked if Mr. Tellez had reviewed the staff report and recommended conditions of approval. Mr. Tellez replied no. Commissioner Sheets recommended that Mr. Tellez review the conditions while other testimony is being taken.

Principal Planner Michelle Barron reviewed the Staff Report for the record.

Commissioner Nevill asked about the difference between an arena and an event center and asked for clarification. Planner Barron stated there are different standards for an event center, however, many of the conditions would be similar for life/safety.

Commissioner Matthews asked Planner Barron to depict on the map where parking and ingress/egress would be located.

Chairman Sturgill asked about the charging for events versus events with no fee. Planner Barron clarified that this is for a commercial arena/charge that would require a permit.

Chairman Sturgill affirmed the witnesses to testify.

Testimony:

Cameron Molroney – IN FAVOR – 21089 Rodeo Ln., Wilder, ID 83676

Mr. Molroney lives west of the subject property. He supports the approval of the conditional use permit. Horses that compete need to have exposure to people and training. The proposed use would not have a negative impact to the community and is an economic benefit to Wilder and Canyon County. He agreed with the conditions recommended by staff.

Tedra Prouty - IN OPPOSITION - 1117 Sunshine Ave., Wilder, ID 83676

Ms. Prouty stated there are two racetracks within two hours of the area. She grew up in California and this racetrack is not even a quarter of the size. To safely turn the horses, it needs a certain size/curvature of the track. She feels this would be unsafe. The fence is made of pallets and falling down. The fence is not made in a manner that would hold animals in. The track is made out of PVC pipe. She was concerned about Peckham Road that is not built for this type of use. Wilder P&Z was not in favor of the request.

Commissioner Matthews asked where the track is located on the map. Ms. Prouty clarified her understanding of where the track was located.

Chairman Sturgill asked the reasons for Wilder not being in favor. Ms. Prouty stated it was primarily in regard to the roads/traffic.

Cindy Foster - IN OPPOSITION - Did not provide a complete address, Wilder, ID

Ms. Foster has lived at her address for 13 years. The area is primarily agricultural and residential. She is concerned about the number of people that would be on site. The arena has been operating for 4-5 years and charges \$40 per car. Ms. Foster stated that they are willing to operate illegally. The loud music and events are not conducive to the area. She is concerned about the alcohol usage and traffic. Ms. Foster wanted clarification on the amount of people that would actually be on the site.

Commissioner Nevill asked how loud the current events are. Ms. Foster clarified that the speakers aren't installed yet, that is new.

Chairman Sturgill asked Ms. Foster if recommended condition no. 14 would ease her concerns. She questioned who would enforce that condition.

Stacie Harvey - IN OPPOSITION - 28378 Fox Ln., Wilder, ID 83676

Ms. Harvey stated the applicant's horses are well kept and there is no abuse. She does have concerns regarding safety and pulling EMS staff to provide service to this use. During hop season there is quite an increase in traffic. She is concerned about loud music and felt the music should be cut off at 10 p.m. Ms. Harvey noted that since the track has been in use there have been cars parked along Peckham Road.

Commissioner Nevill asked Ms. Harvey about her testimony in regard to EMS. He asked if Wilder is a volunteer staff. Ms. Harvey stated it is volunteer.

Commissioner Sheets asked when hop season begins. Ms. Harvey stated in the fall. With the increase in population combined with farming, Peckham Road gets very busy.

Chairman Strugill asked if a fence should be installed around the property. She replied yes, it would be better than the pallets. Chairman Sturgill asked if there were any other conditions that could be placed to help mitigate her concerns. She replied fences and turn lanes.

Dennis Harvey - IN OPPOSITION - 28378 Fox Ln., Wilder, ID 83676

Mr. Harvey's agreed with the concerns previously noted in testimony. He stated that the events have been taking place on the property for years. Mr. Harvey stated that there is not enough room to put in turn lanes. The only entrance is on the south end of the property past the house. He has concerns regarding noise from the events. Mr. Harvey is concerned about the number of people on site, alcohol, & gambling. The area is zoned agriculture and this use is not compatible.

Commissioner Sheets asked if there would be an appropriate area for something like this. He said there are potential locations that are not buried in an agricultural area. The road is only 20 ft wide with no shoulder. 500 people on the site is a lot of vehicles and the infrastructure cannot support it.

Ivan Tellez – (Applicant) REBUTTAL – 27410 Peckham Rd., Wilder, ID 83676

Mr. Tellez spoke through an interpreter. At the trainings only, the trainers and horse owners go, and there are not a lot of people. At the events they invite other people to see how the horses are running/racing. Money is charged to be able to go in to cover expenses, such as insurance. The insurance costs more than \$5,000. Security charges \$40.00 per hour and it is costly to rent the port-a-potty. He is aware that horses are quick but that is why there are fences/rails to separate the horses from the spectators. At the events spectators are not allowed where the horses are. Only the owners & trainers are allowed. He is aware that the fence is made of pallets but he would be changing it to more of a solid one. He is aware a stronger/taller fence is needed to avoid a horse getting out. Training would not take place every day; only three days a week from 5-8 p.m. There are horses on the property right now, and those belong to Mr. Tellez. Mr. Tellez stated that he would be willing to change the events to one per month. He is here to see if an agreement can be reached. He has spoken with the fire department and the chief advised him that an ambulance could be provided for each of the events. Private security would be at each event. He is concerned about the condition requiring revocation if the sheriff is called out twice. Anyone could call, whether or not there was an issue. He was not aware that it was illegal to have events on his property. When he got the letter from the County he cancelled everything.

Commissioner Sheets asked if Mr. Tellez had the opportunity to review the proposed conditions. He replied no. He was listening to the testimony being provided.

Commissioner Nevill asked if he was aware of the hearing Wilder P&Z had held. He replied, no, he did not know anything about those meetings.

Planner Barron stated the materials deadline was February 24, 2025. The date on the agenda for the Wilder P&Z discussion was February 28, 2025. There is a letter in the record from the City of Wilder in which they voiced no opposition to the request and that it was an acceptable use of the property.

Commissioner Nevill asked if he would be willing to pay for turn lanes. Mr. Tellez stated he is willing, but would need time to obtain the funds to do so. Commissioner Nevill asked if Mr. Tellez was okay with the condition that if two legitimate calls are received in a year, the permit could be revoked. Mr. Tellez replied, yes.

A 15-minute recess was taken to allow Mr. Tellez the opportunity to review the recommended conditions of approval.

Chairman Sturgill asked if Mr. Tellez had any concerns with the review of conditions of approval. He indicated that he agrees with them all but needed time to construct the turn in lane. The traffic impact study said it wasn't necessary. Chairman Sturgill asked about restricting the amount of people to 250. Mr. Tellez would like a little more, but if it is not possible, he is ok with that limitation.

Planner Barron stated that when the application was submitted they were applying for a commercial arena. After discussions with staff, the number of people was reduced and the use was clarified. The applicant would be required to comply with Golden Gate Highway District's requirements.

Commissioner Sheets asked about revocation proceedings and whether or not that would come before the P&Z Commission. Planner Barron explained the process and that a revocation would come before the Commission.

MOTION: Commissioner Sheets moved to close public testimony on Case No. CU2022-0008 seconded by Commissioner Matthews. Voice vote, motion carried.

Deliberation:

Chairman Sturgill invited discussion as to whether or not the use can be properly conditioned to be approved.

Commissioner Matthews stated, no. The proposed use would be a fairly large operation in the area. He has traffic concerns.

Commissioner Sheets stated that all of the things they are doing would be allowed, with the exception of charging for events. He does feel that this could properly conditioned.

Commissioner Nevill agreed that the request could be conditioned to help mitigate concerns. The applicant has been receptive to the conditions. Commissioner Nevill said there does need to be some buttoning down of conditions. He is concerned about traffic and there needs to be a right turn lane.

Chairman Sturgill stated he has concerns about the impact. The applicant has been willing to agree to the conditions to help minimize impacts. The use could have the potential to have a benefit to the area, but needs to be conditioned.

Commissioner Matthews stated the neighbors have lived there for years. Their lives may be impacted by this use with noise/traffic. There may be a better location for this use.

Commissioner Sheets stated that EMS should be on site as an addition to either condition 28 or 29. Fencing should be installed but should be clarified of the type and be measurable. The fence should be six foot in ground. He is okay with 250 people.

Commissioner Nevill asked if the condition as written in regard to the highway district would cover the turn lane. Commissioner Sheets stated the highway district has jurisdiction over requirements/traffic studies.

Commissioner Nevill noted there is a condition in regard to noise as far as decibels but another way to control the noise is to reduce the number of events. He is more comfortable with one event.

MOTION: Commissioner Sheets moved to **approve** Case No. CU2022-0008, with the addition of condition 30, to require a 6 ft in-ground fence be installed prior to operations for the purpose of preventing horse escape and modification to condition no. 29 to require EMS service to be on site during events. Modification to finding no. 8 in regard to essential services. Essential services would be adequate as conditioned. Seconded by Commissioner Nevill.

Discussion on the Motion:

Commissioner Nevill stated for the record that conditional use permits are policed by the public and if they notice violations to call.

Roll call vote: 3 in favor, 1 opposed, motion passed.

3. DIRECTOR, PLANNER, COMMISSION COMMENTS:

Commissioner Sheets stated on April 3rd there are many Ordinance cases and the Commission would like to have the packets as soon as possible.

4. ADJOURNMENT:

MOTION: Commissioner Sheets moved to adjourn, seconded by Commissioner Mathews. Voice vote, motion carried. Hearing adjourned at 10:05 P.M

1. BACKGROUND:

The subject parcel was created in its current configuration in 1980 (Tax 8, 18-3N-1W). According to the Assessor's office records, the dwelling was built in 1977. A detached garage was constructed in 1985. Another detached garage and lean-to structure were established in 1998 (Building Permits #ZC2004-1384 & BPMS1998-16939).

The applicants purchased the subject parcel on July 20, 2021 (Instrument No. 2021050798, Exhibit A.5). Based on aerial imagery, the staging area use appears to have been established in early 2022 (Exhibit

B.4). The letter of intent (Exhibit A.2 & A.6) states the property is used for their business, CBI Insulation, which includes the parking of six box trucks and employee parking for nine employees (Exhibit A.4).

On February 14, 2023, the applicants received a notice of violation regarding the establishment of a staging area on the parcel (CDEF2023-0035, Exhibit B.3). A staging area is not allowed in the "R-R" (Rural Residential) zone (CCCO §07-10-27, Exhibit B.5).

On March 9, 2023, the applicant submitted a conditional rezoning application to amend the current zone to a "C-1" Zone subject to a development agreement limiting uses to a contractor shop and staging area use (Exhibit A). DSD staff included the caretaker residence use due to residential dwellings being prohibited in the "C-1" zone. If approved, a contractor shop use requires a conditional use permit (CCCO §07-10-27, Exhibit B.5).

2. HEARING BODY ACTION:

Pursuant to Canyon County Code of Ordinances (CCCO) Section 07-06-01(3) requests for comprehensive plan changes and ordinance amendments may be consolidated for notice and hearing purposes. Although these procedures can be considered in tandem, pursuant to Idaho Code section 67-6511(b), the commission, and subsequently the board, shall deliberate first on the proposed amendment to the comprehensive plan; then, once the commission, and subsequently the board, has made that determination, the commission, and the board, should decide the appropriateness of a rezone within that area. This procedure provides that the commission, and subsequently the board, considers the overall development scheme of the county prior to consideration of individual requests for amendments to zoning ordinances. The commission, and subsequently the board, should make clear which of its findings relate to the proposed amendment to the comprehensive plan and which of its findings relate to the request for an amendment to the zoning ordinance.

Pursuant to CCCO Section 07-06-07(1) Restrictions: In approving a conditional rezone application, the presiding party may establish conditions, stipulations, restrictions, or limitations which restrict and limit the use of the rezoned property to less than the full use allowed under the requested zone, and which impose specific property improvement and maintenance requirements upon the requested land use. Such conditions, stipulations, restrictions, or limitations may be imposed to promote the public health, safety, and welfare, or to reduce any potential damage, hazard, nuisance, or other detriment to persons or property in the vicinity to make the land use more compatible with neighboring land uses. When the presiding party finds that such conditions, stipulations, restrictions, or limitations are necessary, land may be rezoned upon condition that if the land is not used as approved, or if an approved use ends, the land use will revert back to the zone applicable to the land immediately prior to the conditional rezone action.

Additionally, pursuant to CCCO Section 07-06-07(3) Conditional Rezoning Designation: Such restricted land shall be designated by a CR (conditional rezoning) on the official zoning map upon approval of a resolution by the board for an "order of intent to rezone". An "order of intent to rezone" shall be submitted to the board for approval once the specific use has commenced on the property and all required conditions of approval have been met and any required improvements are in place. Land uses that require approval of a subdivision shall have an approved final plat in accordance with this chapter before the "order of intent to rezone" is submitted for approval by the board. Designation of a parcel as CR shall not constitute "spot" zoning and shall not be presumptive proof that the zoning of other property adjacent to or in the vicinity of the conditionally rezoned property should be rezoned the same.

Should the Commission wish to approve the subject conditional rezone, all applicable Canyon County standards pertaining to the required development agreement shall be strictly adhered to.

The commission should consider the procedures outlined above within CCCO Section 07-06-01(3).

6. SUMMARY & RECOMMENDED CONDITIONS:

In consideration of the application and supporting materials, staff concludes that the proposed conditional rezone <u>is not</u> **compliant** with Canyon County Code of Ordinances §07-06-07(6). A full analysis is detailed within the staff report.

If the Planning and Zoning Commission recommends approval of the request to the Board of County Commissioners, the following conditions of the development agreement should be considered:

- 1. Prior to the commencement of use, development shall comply with all applicable federal, state, and county laws, ordinances, rules, and regulations. Compliance includes (but not limited to):
 - a. Southwest District Health requests the applicant meet regarding the request (Exhibit D.4).
 - b. Nampa-Meridian Irrigation District requests all drainage be maintained on-site (Exhibit D.2).
 - c. Nampa Highway District #1 requires commercial accesses to be a paved apron installed per ACCHD Standard Drawing #ACCHD-106 (Exhibit D.6).
 - i. Compliance is required within 3 months of approval.
- 2. The subject parcel, R34456, approximately 1.05 acres as described in Exhibit ____ (reserved for *legal description*) will be zoned "CR-C-1" (Conditional Rezone Neighborhood Commercial) subject to the following conditions:
 - a. Uses are limited to the following:
 - i. Staging Area subject to compliance with all use standards (CCCO Section 07-14-29) and applicant's letter of intent regarding the staging area hour of operation, fencing, and employee parking (Exhibit A.2);
 - Compliance is required within 3 months of approval.
 - ii. Contractor Shop subject to conditional use permit approval; and

- iii. Caretaker residence.
- b. The "C-1" Zone and limited uses shall expire and cease if the parcel is annexed into the City of Nampa.
- 3. The developer shall comply with CCCO §07-06-07(4): Time Requirements: "All conditional rezone for a land use shall commence within two (2) years of the approval of the board."

To Whom It May Concern,

We are submitting this Letter of Intent along with our master application for a Conditional Rezone of our property at 6019 Stamm Ln, Nampa, ID 83687. Due to our recent receipt of Notice of Violation, we were made aware that we are currently zoned Rural Residential (RR) and that we are in violation of the Staging Area portion of the code. This is due to parking our 6 box trucks for our business, CBI Insulation (CBI), and our employee vehicles in our lower parking lot.

We were unaware that we were violating any codes, as we specifically purchased this property almost 2 years ago and have been using it for our trucks and employee vehicles since that time. The prior owners <u>also</u> used this property for business activities. We also reside in our personal home on the property.

We believe that a Conditional Rezone of our parcel is completely consistent with the future zoning in this area. The 2040 Nampa Comprehensive Plan shows a rezoning of this entire area to a zoning description that allows for mixed use.

Our request will **not** impact the character of the area. There are no agricultural or basic rural areas close to us any longer. Also, as mentioned above, we have been using this property for our business parking for almost 2 years. There are multiple other businesses in the immediate surrounding area, most of which have company vehicles, employee vehicles, etc. at them at times during the day.

CBI does <u>not</u> perform any retail or wholesale activities from this property, nor make any excessive noise. The most noise made is the opening and closing of the doors, and the truck/vehicle start-ups. Our standard working hours for our employees are 6:30 a.m. to approximately 4:30 p.m. We set these hours so that we could avoid any high traffic times along Stamm Lane. The employees arrive in the morning, park their personal vehicles in our lot, and take the CBI Insulation box trucks and leave for the day returning after work and leaving.

As far as adequate facilities (i.e. sewer, water, irrigation, utilities) are concerned, none of these are required for the parking lot. We have a shop on the lot that has a restroom in it for any sanitary needs our employees may have while picking up the company vehicles.

We have full legal access to our property. We have 3 entrances, 2 of which are designated for our employees and entry/exit of our trucks. Upon purchase of this property, we met with the Nampa Road Department to verify that we are "grandfathered" in to have our 3rd access for the parking area.

We will <u>not</u> need any public street improvements for adequate access that would minimize interference with Stamm Lane.

Upon approval by the County for a conditional re-zone, we should not need to make any further changes to our property. We have already made some significant improvements as follows:

*Upon purchase of this property, we installed a full perimeter, 5 foot tall solid vinyl fence with 3 gates in order to isolate the parking area from Stamm Lane**

*We also installed an electrical fixture on our property that helps to light up the area along Stamm in front of our property that shines directly on Stamm where the School Bus stop is – lighting the area for the children while they wait for the bus.

CBI is a business that we started in 2008, and it has been running successfully since that time. We strive to follow all laws and regulations, and would like to continue to use our personal property for staging/parking as we have been. Our success is partially due to our ability to keep our overhead costs down, which is why we purchased this property.

We held our neighborhood meeting on Tuesday, March 7, 2023. Out of 30 neighbors notified, 2 showed up and they both indicated they have absolutely no concerns with our use of the property.

CBI Insulation fulfills the needs of our close neighbors, customers and all clients by providing great service and we are involved both personally and with CBI in supporting the local community!

We would like to request that Canyon County allow us a conditional rezone of our property to a C1 so that we are no longer in violation of Code CCZO 07-10-27 for the parking/staging area. We appreciate your consideration on this matter.


(Q) "RESPA" means the Real Estate Settlement Procedures Act (12 U.S.C. §2601 et seq.) and its implementing regulation, Regulation X (12 C.F.R. Part 1024), as they might be amended from time to time, or any additional or successor legislation or regulation that governs the same subject matter. As used in this Security Instrument, "RESPA" refers to all requirements and restrictions that are imposed in regard to a "federally related mortgage loan" even if the Loan does not qualify as a "federally related mortgage loan" under RESPA.

(R) "Successor in Interest of Borrower" means any party that has taken title to the Property, whether or not that party has assumed Borrower's obligations under the Note and/or this Security Instrument.

TRANSFER OF RIGHTS IN THE PROPERTY

The beneficiary of this Security Instrument is MERS (solely as nominee for Lender and Lender's successors and assigns) and the successors and assigns of MERS. This Security Instrument secures to Lender: (i) the repayment of the Loan, and all renewals, extensions and modifications of the Note; and (ii) the performance

of Borrower's covenants and agreements under this Security Instrument and the Note. For this purpose, Borrower irrevocably grants and conveys to Trustee, in trust, with power of sale, the following described property located in the COUNTY of CANYON:

TOGETHER WITH all the improvements now or hereafter erected on the property, and all easements, appurtenances, and fixtures now or hereafter a part of the property. All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property." Borrower understands and agrees that MERS holds only legal title to the interests granted by Borrower in this Security Instrument, but, if necessary to comply with law or custom, MERS (as nominee for Lender and Lender's successors and assigns) has the right: to exercise any or all of those interests, including, but not limited to, the right to foreclose and sell the Property; and to take any action required of Lender including, but not limited to, releasing and canceling this Security Instrument.

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.


THIS SECURITY INSTRUMENT combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property.

UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Borrower shall pay when due the principal of, and interest on, the debt evidenced by the Note and any prepayment charges and late charges due under the Note. Borrower shall also pay funds for Escrow Items pursuant to Section 3. Payments due under the Note and this Security Instrument shall be made in U.S. currency. However, if any check or other instrument received by Lender as payment under the Note or this Security Instrument is returned to Lender unpaid, Lender may require that any or all subsequent payments due under the Note and this Security Instrument be made in one or more of the following forms, as selected by Lender: (a) cash; (b) money order; (c) certified check, bank check, treasurer's check or cashier's check, provided any such check is drawn upon an institution whose deposits are insured by a federal agency, instrumentality, or entity; or (d) Electronic Funds Transfer.

Payments are deemed received by Lender when received at the location designated in the Note or at such other location as may be designated by Lender in accordance with the notice provisions in Section 15. Lender may return any payment or partial payment if the payment or partial payments are insufficient to bring the Loan current. Lender may accept any payment or partial payment insufficient to bring the Loan current, without waiver of any rights hereunder or prejudice to its rights to refuse such payment or partial payments in the future, but Lender is not obligated to apply such payments at the time such payments are accepted. If each Periodic Payment is applied as of its scheduled due date, then Lender need not pay interest on unapplied funds. Lender may hold such unapplied funds until Borrower makes payment to bring the Loan current. If Borrower does not do so within a reasonable period of time, Lender shall either apply such funds or return them to Borrower. If not applied earlier, such funds will be applied to the outstanding principal

balance under the Note immediately prior to foreclosure. No offset or claim which Borrower might have now or in the future against Lender shall relieve Borrower from making payments due under the Note and this Security Instrument or performing the covenants and agreements secured by this Security Instrument.

2. Application of Payments or Proceeds. Except as otherwise described in this Section 2, all payments accepted and applied by Lender shall be applied in the following order of priority: (a) interest due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. Such payments shall be applied to each Periodic Payment in the order in which it became due. Any remaining amounts shall be applied first to late charges, second to any other amounts due under this Security Instrument, and then to reduce the principal balance of the Note.


If Lender receives a payment from Borrower for a delinquent Periodic Payment which includes a sufficient amount to pay any late charge due, the payment may be applied to the delinquent payment and the late charge. If more than one Periodic Payment is outstanding, Lender may apply any payment received from Borrower to the repayment of the Periodic Payments if, and to the extent that, each payment can be paid in full. To the extent that any excess exists after the payment is applied to the full payment of one or more Periodic Payments, such excess may be applied to any late charges due. Voluntary prepayments shall be applied first to any prepayment charges and then as described in the Note.

Any application of payments, insurance proceeds, or Miscellaneous Proceeds to principal due under the Note shall not extend or postpone the due date, or change the amount, of the Periodic Payments.

3. Funds for Escrow Items. Borrower shall pay to Lender on the day Periodic Payments are due under the Note, until the Note is paid in full, a sum (the "Funds") to provide for payment of amounts due for: (a) taxes and assessments and other items which can attain priority over this Security Instrument as a lien or encumbrance on the Property; (b) leasehold payments or ground rents on the Property, if any; (c) premiums for any and all insurance required by Lender under Section 5; and (d) Mortgage Insurance premiums, if any, or any sums payable by Borrower to Lender in lieu of the payment of Mortgage Insurance premiums in accordance with the provisions of Section 10. These items are called "Escrow Items." At origination or at any time during the term of the Loan, Lender may require that Community Association Dues, Fees, and Assessments, if any, be escrowed by Borrower, and such dues, fees and assessments shall be an Escrow Item. Borrower shall promptly furnish to Lender all notices of amounts to be paid under this Section. Borrower shall pay Lender the Funds for Escrow Items unless Lender waives Borrower's obligation to pay the Funds for any or all Escrow Items. Lender may waive Borrower's obligation to pay to Lender Funds for any or all Escrow Items at any time. Any such waiver may only be in writing. In the event of such waiver, Borrower shall pay directly, when and where payable, the amounts due for any Escrow Items for which payment of Funds has been waived by Lender and, if Lender requires, shall furnish to Lender receipts evidencing such payment within such time period as Lender may require. Borrower's obligation to make such payments and to provide receipts shall for all purposes be deemed to be a covenant and agreement contained in this Security Instrument, as the phrase "covenant and agreement" is used in Section 9. If Borrower is obligated to pay Escrow Items directly, pursuant to a waiver, and Borrower fails to pay the amount due for an Escrow Item, Lender may exercise its rights under Section 9 and pay such amount and Borrower shall then be obligated under Section 9 to repay to Lender any such amount. Lender may revoke the waiver as to any or all Escrow Items at any time by a notice given in accordance with Section 15 and, upon such revocation, Borrower shall pay to Lender all Funds, and in such amounts, that are then required under this Section 3.

Lender may, at any time, collect and hold Funds in an amount (a) sufficient to permit Lender to apply the Funds at the time specified under RESPA, and (b) not to exceed the maximum amount a lender can require under RESPA. Lender shall estimate the amount of Funds due on the basis of current data and reasonable estimates of expenditures of future Escrow Items or otherwise in accordance with Applicable Law.

The Funds shall be held in an institution whose deposits are insured by a federal agency, instrumentality, or entity (including Lender, if Lender is an institution whose deposits are so insured) or in any Federal Home Loan Bank. Lender shall apply the Funds to pay the Escrow Items no later than the time specified under RESPA. Lender shall not charge Borrower for holding and applying the Funds, annually analyzing the escrow account, or verifying the Escrow Items, unless Lender pays Borrower interest on the Funds and Applicable Law permits Lender to make such a charge. Unless an agreement is made in writing or Applicable Law requires interest to be paid on the Funds, Lender shall not be required to pay Borrower any interest or earnings on the Funds. Borrower and Lender can agree in writing, however, that interest shall be paid on the Funds. Lender shall give to Borrower, without charge, an annual accounting of the Funds as required by RESPA.

If there is a surplus of Funds held in escrow, as defined under RESPA, Lender shall account to Borrower for the excess funds in accordance with RESPA. If there is a shortage of Funds held in escrow, as defined under RESPA, Lender shall notify Borrower as required by RESPA, and Borrower shall pay to Lender the amount necessary to make up the shortage in accordance with RESPA, but in no more than 12 monthly payments. If there is a deficiency of Funds held in escrow, as defined under RESPA, Lender shall notify Borrower as required by RESPA, and Borrower shall pay to Lender the amount necessary to make up the deficiency in accordance with RESPA, but in no more than 12 monthly payments.

Upon payment in full of all sums secured by this Security Instrument, Lender shall promptly refund to Borrower any Funds held by Lender.


4. Charges; Liens. Borrower shall pay all taxes, assessments, charges, fines, and impositions attributable to the Property which can attain priority over this Security Instrument, leasehold payments or ground rents on the Property, if any, and Community Association Dues, Fees, and Assessments, if any. To the extent that these items are Escrow Items, Borrower shall pay them in the manner provided in Section 3.

Borrower shall promptly discharge any lien which has priority over this Security Instrument unless Borrower: (a) agrees in writing to the payment of the obligation secured by the lien in a manner acceptable to Lender, but only so long as Borrower is performing such agreement; (b) contests the lien in good faith by, or defends against enforcement of the lien in, legal proceedings which in Lender's opinion operate to prevent the enforcement of the lien while those proceedings are pending, but only until such proceedings are concluded; or (c) secures from the holder of the lien an agreement satisfactory to Lender subordinating the lien to this Security Instrument. If Lender determines that any part of the Property is subject to a lien which can attain priority over this Security Instrument, Lender may give Borrower a notice identifying the lien. Within 10 days of the date on which that notice is given, Borrower shall satisfy the lien or take one or more of the actions set forth above in this Section 4.

Lender may require Borrower to pay a one-time charge for a real estate tax verification and/or reporting service used by Lender in connection with this Loan.

5. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. Lender may require Borrower to pay, in connection with this Loan, either: (a) a one-time charge for flood zone determination, certification and tracking services; or (b) a one-time charge for flood zone determination and certification services and subsequent charges each time remappings or similar changes occur which reasonably might affect such

determination or certification. Borrower shall also be responsible for the payment of any fees imposed by the Federal Emergency Management Agency in connection with the review of any flood zone determination resulting from an objection by Borrower.

If Borrower fails to maintain any of the coverages described above, Lender may obtain insurance coverage, at Lender's option and Borrower's expense. Lender is under no obligation to purchase any particular type or amount of coverage. Therefore, such coverage shall cover Lender, but might or might not protect Borrower, Borrower's equity in the Property, or the contents of the Property, against any risk, hazard or liability and might provide greater or lesser coverage than was previously in effect. Borrower acknowledges that the cost of the insurance coverage so obtained might significantly exceed the cost of insurance that Borrower could have obtained. Any amounts disbursed by Lender under this Section 5 shall become additional debt of Borrower secured by this Security Instrument. These amounts shall bear interest at the Note rate from the date of disbursement and shall be payable, with such interest, upon notice from Lender to Borrower requesting payment.

All insurance policies required by Lender and renewals of such policies shall be subject to Lender's right to disapprove such policies, shall include a standard mortgage clause, and shall name Lender as mortgagee and/or as an additional loss payee. Lender shall have the right to hold the policies and renewal certificates. If Lender requires, Borrower shall promptly give to Lender all receipts of paid premiums and renewal notices. If Borrower obtains any form of insurance coverage, not otherwise required by Lender, for damage to, or destruction of, the Property, such policy shall include a standard mortgage clause and shall name Lender as mortgage and/or as an additional loss payee.


In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower. Unless Lender and Borrower otherwise agree in writing, any insurance proceeds, whether or not the underlying insurance was required by Lender, shall be applied to restoration or repair of the Property, if the restoration or repair is economically feasible and Lender's security is not lessened. During such repair and restoration period, Lender shall have the right to hold such insurance proceeds until Lender has had an opportunity to inspect such Property to ensure the work has been completed to Lender's satisfaction, provided that such inspection shall be undertaken promptly. Lender may disburse proceeds for the repairs and restoration in a single payment or in a series of progress payments as the work is completed. Unless an agreement is made in writing or Applicable Law requires interest to be paid on such insurance proceeds, Lender shall not be required to pay Borrower any interest or earnings on such proceeds. Fees for public adjusters, or other third parties, retained by Borrower shall not be paid out of the insurance proceeds and shall be the sole obligation of Borrower. If the restoration or repair is not economically feasible or Lender's security would be lessened, the insurance proceeds shall be applied to the sums secured by this Security Instrument, whether or not then due, with the excess, if any, paid to Borrower. Such insurance proceeds shall be applied in the order provided for in Section 2.

If Borrower abandons the Property, Lender may file, negotiate and settle any available insurance claim and related matters. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the claim. The 30-day period will begin when the notice is given. In either event, or if Lender acquires the Property under Section 22 or otherwise, Borrower hereby assigns to Lender (a) Borrower's rights to any insurance proceeds in an amount not to exceed the amounts unpaid under the Note or this Security Instrument, and (b) any other of Borrower's rights (other than the right to any refund of unearned premiums paid by Borrower) under all insurance policies covering the Property, insofar as such rights are applicable to the coverage of the Property. Lender may use the insurance proceeds either to repair or restore the Property or to pay amounts unpaid under the Note or this Security Instrument, whether or not then due.

6. Occupancy. Borrower shall occupy, establish, and use the Property as Borrower's principal

residence within 60 days after the execution of this Security Instrument and shall continue to occupy the Property as Borrower's principal residence for at least one year after the date of occupancy, unless Lender otherwise agrees in writing, which consent shall not be unreasonably withheld, or unless extenuating circumstances exist which are beyond Borrower's control.

7. Preservation, Maintenance and Protection of the Property; Inspections. Borrower shall not destroy, damage or impair the Property, allow the Property to deteriorate or commit waste on the Property. Whether or not Borrower is residing in the Property, Borrower shall maintain the Property in order to prevent the Property from deteriorating or decreasing in value due to its condition. Unless it is determined pursuant to Section 5 that repair or restoration is not economically feasible, Borrower shall promptly repair the Property if damaged to avoid further deterioration or damage. If insurance or condemnation proceeds are paid in connection with damage to, or the taking of, the Property, Borrower shall be responsible for repairing or restoring the Property only if Lender has released proceeds for such purposes. Lender may disburse proceeds for the repairs and restoration in a single payment or in a series of progress payments as the work is completed. If the insurance or condemnation proceeds are not sufficient to repair or restore the Property, Borrower is not relieved of Borrower's obligation for the completion of such repair or restoration.

Lender or its agent may make reasonable entries upon and inspections of the Property. If it has reasonable cause, Lender may inspect the interior of the improvements on the Property. Lender shall give Borrower notice at the time of or prior to such an interior inspection specifying such reasonable cause.

8. Borrower's Loan Application. Borrower shall be in default if, during the Loan application process. Borrower or any persons or entities acting at the direction of Borrower or with Borrower's knowledge or consent gave materially false, misleading, or inaccurate information or statements to Lender (or failed to provide Lender with material information) in connection with the Loan. Material representations include, but are not limited to, representations concerning Borrower's occupancy of the Property as Borrower's principal residence.

9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. If (a) Borrower fails to perform the covenants and agreements contained in this Security Instrument, (b) there is a legal proceeding that might significantly affect Lender's interest in the Property and/or rights under this Security Instrument (such as a proceeding in bankruptcy, probate, for condemnation or forfeiture, for enforcement of a lien which may attain priority over this Security Instrument or to enforce laws or regulations), or (c) Borrower has abandoned the Property, then Lender may do and pay for whatever is reasonable or appropriate to protect Lender's interest in the Property and rights under this Security Instrument, including protecting and/or assessing the value of the Property, and securing and/or repairing the Property. Lender's actions can include, but are not limited to: (a) paying any sums secured by a lien which has priority over this Security Instrument; (b) appearing in court; and (c) paying reasonable attorneys' fees to protect its interest in the Property and/or rights under this Security Instrument, including its secured position in a bankruptcy proceeding. Securing the Property includes, but is not limited to, entering the Property to make repairs, change locks, replace or board up doors and windows, drain water from pipes, eliminate building or other code violations or dangerous conditions, and have utilities turned on or off. Although Lender may take action under this Section 9, Lender does not have to do so and is not under any duty or obligation to do so. It is agreed that Lender incurs no liability for not taking any or all actions authorized under this Section 9.

Any amounts disbursed by Lender under this Section 9 shall become additional debt of Borrower secured by this Security Instrument. These amounts shall bear interest at the Note rate from the date of disbursement and shall be payable, with such interest, upon notice from Lender to Borrower requesting payment.

If this Security Instrument is on a leasehold, Borrower shall comply with all the provisions of the

lease. Borrower shall not surrender the leasehold estate and interests herein conveyed or terminate or cancel the ground lease. Borrower shall not, without the express written consent of Lender, alter or amend the ground lease. If Borrower acquires fee title to the Property, the leasehold and the fee title shall not merge unless Lender agrees to the merger in writing.

10. Mortgage Insurance. If Lender required Mortgage Insurance as a condition of making the Loan, Borrower shall pay the premiums required to maintain the Mortgage Insurance in effect. If, for any reason, the Mortgage Insurance coverage required by Lender ceases to be available from the mortgage insurer that previously provided such insurance and Borrower was required to make separately designated payments toward the premiums for Mortgage Insurance, Borrower shall pay the premiums required to obtain coverage substantially equivalent to the Mortgage Insurance previously in effect, at a cost substantially equivalent to the cost to Borrower of the Mortgage Insurance previously in effect, from an alternate mortgage insurer selected by Lender. If substantially equivalent Mortgage Insurance coverage is not available, Borrower shall continue to pay to Lender the amount of the separately designated payments that were due when the insurance coverage ceased to be in effect. Lender will accept, use and retain these payments as a non-refundable loss reserve in lieu of Mortgage Insurance. Such loss reserve shall be non-refundable, notwithstanding the fact that the Loan is ultimately paid in full, and Lender shall not be required to pay Borrower any interest or earnings on such loss reserve. Lender can no longer require loss reserve payments if Mortgage Insurance coverage (in the amount and for the period that Lender requires) provided by an insurer selected by Lender again becomes available, is obtained, and Lender requires separately designated payments toward the premiums for Mortgage Insurance. If Lender required Mortgage Insurance as a condition of making the Loan and Borrower was required to make separately designated payments toward the premiums for Mortgage Insurance, Borrower shall pay the premiums required to maintain Mortgage Insurance in effect, or to provide a non-refundable loss reserve, until Lender's requirement for Mortgage Insurance ends in accordance with any written agreement between Borrower and Lender providing for such termination or until termination is required by Applicable Law. Nothing in this Section 10 affects Borrower's obligation to pay interest at the rate provided in the Note.

Mortgage Insurance reimburses Lender (or any entity that purchases the Note) for certain losses it may incur if Borrower does not repay the Loan as agreed. Borrower is not a party to the Mortgage Insurance.

Mortgage insurers evaluate their total risk on all such insurance in force from time to time, and may enter into agreements with other parties that share or modify their risk, or reduce losses. These agreements are on terms and conditions that are satisfactory to the mortgage insurer and the other party (or parties) to these agreements. These agreements may require the mortgage insurer to make payments using any source of funds that the mortgage insurer may have available (which may include funds obtained from Mortgage Insurance premiums).

As a result of these agreements, Lender, any purchaser of the Note, another insurer, any reinsurer, any other entity, or any affiliate of any of the foregoing, may receive (directly or indirectly) amounts that derive from (or might be characterized as) a portion of Borrower's payments for Mortgage Insurance, in exchange for sharing or modifying the mortgage insurer's risk, or reducing losses. If such agreement provides that an affiliate of Lender takes a share of the insurer's risk in exchange for a share of the premiums paid to the insurer, the arrangement is often termed "captive reinsurance." Further:

(a) Any such agreements will not affect the amounts that Borrower has agreed to pay for Mortgage Insurance, or any other terms of the Loan. Such agreements will not increase the amount Borrower will owe for Mortgage Insurance, and they will not entitle Borrower to any refund.

(b) Any such agreements will not affect the rights Borrower has - if any - with respect to the Mortgage Insurance under the Homeowners Protection Act of 1998 or any other law. These rights may include the right to receive certain disclosures, to request and obtain cancellation of the Mortgage

Insurance, to have the Mortgage Insurance terminated automatically, and/or to receive a refund of any Mortgage Insurance premiums that were uncarned at the time of such cancellation or termination.

11. Assignment of Miscellaneous Proceeds; Forfeiture. All Miscellaneous Proceeds are hereby assigned to and shall be paid to Lender.

If the Property is damaged, such Miscellaneous Proceeds shall be applied to restoration or repair of the Property, if the restoration or repair is economically feasible and Lender's security is not lessened. During such repair and restoration period, Lender shall have the right to hold such Miscellaneous Proceeds until Lender has had an opportunity to inspect such Property to ensure the work has been completed to Lender's satisfaction, provided that such inspection shall be undertaken promptly. Lender may pay for the repairs and restoration in a single disbursement or in a series of progress payments as the work is completed. Unless an agreement is made in writing or Applicable Law requires interest to be paid on such Miscellaneous Proceeds, Lender shall not be required to pay Borrower any interest or earnings on such Miscellaneous Proceeds. If the restoration or repair is not economically feasible or Lender's security would be lessened, the Miscellaneous Proceeds shall be applied to the sums secured by this Security Instrument, whether or not then due, with the excess, if any, paid to Borrower. Such Miscellaneous Proceeds shall be applied in the order provided for in Section 2.

In the event of a total taking, destruction, or loss in value of the Property, the Miscellaneous Proceeds shall be applied to the sums secured by this Security Instrument, whether or not then due, with the excess, if any, paid to Borrower.


In the event of a partial taking, destruction, or loss in value of the Property in which the fair market value of the Property immediately before the partial taking, destruction, or loss in value is equal to or greater than the amount of the sums secured by this Security Instrument immediately before the partial taking, destruction, or loss in value, unless Borrower and Lender otherwise agree in writing, the sums secured by this Security Instrument shall be reduced by the amount of the Miscellaneous Proceeds multiplied by the following fraction: (a) the total amount of the sums secured immediately before the partial taking, destruction, or loss in value divided by (b) the fair market value of the Property immediately before the partial taking, destruction, or loss in value. Any balance shall be paid to Borrower.

In the event of a partial taking, destruction, or loss in value of the Property in which the fair market value of the Property immediately before the partial taking, destruction, or loss in value is less than the amount of the sums secured immediately before the partial taking, destruction, or loss in value, unless Borrower and Lender otherwise agree in writing, the Miscellaneous Proceeds shall be applied to the sums secured by this Security Instrument whether or not the sums are then due.

If the Property is abandoned by Borrower, or if, after notice by Lender to Borrower that the Opposing Party (as defined in the next sentence) offers to make an award to settle a claim for damages, Borrower fails to respond to Lender within 30 days after the date the notice is given, Lender is authorized to collect and apply the Miscellaneous Proceeds either to restoration or repair of the Property or to the sums secured by this Security Instrument, whether or not then due. "Opposing Party" means the third party that owes Borrower Miscellaneous Proceeds or the party against whom Borrower has a right of action in regard to Miscellaneous Proceeds.

13. Joint and Several Liability; Co-signers; Successors and Assigns Bound. Borrower covenants and agrees that Borrower's obligations and liability shall be joint and several. Trustee shall apply the proceeds of the sale in the following order: (a) to all expenses of the sale, including, but not limited to, reasonable Trustee's and





We are submitting this Letter in response to the Public Hearing Notice we received for our Conditional Rezone request for our property at 6019 Stamm Ln, Nampa, ID 83687. We would like to thank you for the progress on our application, and subsequent Public Hearing Notice for March 6th. Both Charles and Linda will attend the public hearing, but also wanted to send in this letter with regards to the rezone app.

Our initial application for re-zoning was due to a violation we received for the zoning ordinance for Staging Area in Rural Residential. We own CBI Insulation and run a small office for Charles and myself in our home. We park 5 box trucks in our parking lot on our property, which is the reason we received the zoning violation. We do not have a contracting business operating from the shop. We use the parking lot for our fleet and our employees only. Currently we have 4 employees who arrive at 6:30 a.m., pick up the box trucks, and leave for the entire day. They return between 4:30 and 5:00, park the trucks, and leave. Our shop is used for storage of their tools and miscellaneous supplies, as well as a small area to hold employee meetings if required.

We feel that the Agency Notice that was distributed to the county, city, government, and public entities could have represented our intentions in a clearer manner with more of our personal background on this. We were not requesting the re-zone to start a contractor shop, only hoping that we could continue to park our fleet vehicles in our lot. The re-zone to commercial was the only way to accomplish this and not be in violation of the zoning ordinance. CBI does **not** perform any retail, wholesale or onsite activities from this property.

We were unaware that we were violating any codes, as we specifically purchased this property in 2021 and for 4 years, we have been using it for our trucks and employee vehicles. The prior owners had a Mechanic business at this property. There are also several other businesses up and down Stamm and surrounding areas which have company and employee vehicles at them.

We read through some of the Agency Notice responses and feel that our request will <u>not</u> impact the sewer, water, irrigation, utilities, or public roads. Again, we have been staging our vehicles here for 4 years and haven't impacted any emergency services or other entities. We understand the City of Nampa's concern that our rezone does not fit into the future plan for low density residential, but we have not impacted the city in any way and would not change what we currently do on our property. We would be willing to meet the Highway District's request that our driveway needs to have a paved apron entrance.

We would like to request that Canyon County reconsider some of the negative responses and allow us a conditional rezone of our property so that we are no longer in violation of Code CCZO 07-10-27 for the parking/staging area. Dear Mr. Lister,

The Engineering Department has reviewed the application submitted for Case No. CR2023-0005, in which Linda and Charles Lowery are requesting a conditional rezone of Parcel R24645 from Rural Residential (R-R) to Neighborhood Commercial (C-1), with a development agreement limiting the use to a contractor shop, staging area, and caretaker unit.

Our comments are as follows:

1. Adequacy of Facilities and Services (Sewer, Water, Drainage, Irrigation, and Utilities):

It is essential that the applicant confirms the adequacy of the existing utility infrastructure to support the proposed rezone. This includes water supply, wastewater management, and drainage systems. The Engineering Department has no immediate concerns, but the applicant should work with local utility providers to ensure that capacity and access are sufficient for the proposed contractor shop and staging area. Any required extensions or upgrades should be identified and implemented prior to development.

2. Public Street Improvements and Traffic Impact Mitigation:

Stamm Lane must be evaluated for its ability to handle any increase in commercial traffic associated with the proposed contractor shop and staging area. A traffic impact study may be necessary to determine if road improvements or traffic control measures are required. If the rezone results in a significant increase in commercial vehicle traffic, the applicant should explore options to minimize disruptions, such as roadway widening or improved ingress/egress. Coordination with the local transportation district is essential.

3. Legal Access and Easements:

Based on the materials provided, access to the property via Stamm Lane appears to be legally established and sufficient. However, we recommend that any existing access easements be reviewed to ensure that they are adequately documented for the proposed commercial use, and that emergency access is clearly defined.

4. Irrigation System and Water Rights:

If irrigation is currently provided to the property, the applicant should ensure that the development does not disrupt the irrigation system or infringe on water rights. Any necessary adjustments to irrigation lines or easements must be coordinated with the local irrigation district.

Conclusion:

We recommend that the applicant address these concerns before the final approval of the rezone.

FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

In the matter of the application of: **Bowery – CR2023-0005**

The Canyon County Board of County Commissioners considers the following:

- Conditional Rezone of Parcel R24645, approximately 1.05 acres, from an "R-R" (Rural Residential) zone to a C-1 (Neighborhood Commercial) zone.
- 2) Development agreement to limit commercial use to a contractor shop, staging area, and caretaker unit.
- Location: 6019 Stamm Lane, Nampa (Parcel R24645), also referenced as a portion of the SE¹/₄ of Section 18, T3N, R1W, Canyon County, Idaho.

Summary of the Record

- 1. The record is comprised of the following:
 - A. The record includes all testimony, the staff report, exhibits, and documents in Case File CR2023-0005.
 - 1. See Board of County Commissioners Staff Report Addendum dated June 11, 2025, for all exhibits.

Applicable Law

- The following laws and ordinances apply to this decision: Canyon County Code of Ordinances (CCCO) §01-17 (Land Use/Land Division Hearing Procedures), CCCO§07-05 (Notice, Hearing and Appeal Procedures), CCCO§07-06-01 (Initiation of Proceedings), CCCO§07-06-07 (Conditional Rezones), CCCO §07-10-27 (Land Use Regulations (Matrix)), Idaho Code §67-6511 (Zoning Map Amendments and Procedures), and CCCO §09-11-25(Area of City Impact Agreement).
 - a. Notice of the public hearing was provided per CCCO §07-05-01 and Idaho Code §67-6509.
 - b. The presiding party may establish conditions, stipulations, restrictions, or limitations which restrict and limit the use of the rezoned property to less than the full use allowed under the requested zone, and which impose specific property improvement and maintenance requirements upon the requested land use. Such conditions, stipulations, restrictions, or limitations may be imposed to promote the public health, safety, and welfare, or to reduce any potential damage, hazard, nuisance, or other detriment to persons or property in the vicinity, to make the land use more compatible with neighboring land uses. *See* CCCO §07-06-07(1).
 - c. All conditional rezones for land use shall commence within two (2) years of the approval of the board. If the conditional rezone has not commenced within the stated time requirement, the application for a conditional rezone shall lapse and become void. *See* CCCO §07-05-01
- 2. The Board has the authority to exercise powers granted to it by the Idaho Local Land Use and Planning Act ("LLUPA") and can establish its own ordinances regarding land use. *See* I.C. §67-6504, §67-6511.
- 3. The Board has the authority to hear this case and make its own independent determination. *See* I.C. §67-6519, §67-6504, 67-6509 & 67-6511.
- 4. The Board can sustain, modify or reject the Commission's recommendations. *See* CCCO §07-05-03.
- 5. The burden of persuasion is upon the applicant to prove that all criteria are satisfied. CCCO §07-05-03.
- 6. Idaho Code §67-6535(2) requires the following: The approval or denial of any application required or authorized pursuant to this chapter shall be in writing and accompanied by a reasoned statement that explains the criteria and standards considered relevant, states the relevant contested facts relied upon, and explains the rationale for the decision based on the applicable provisions of the comprehensive plan, relevant ordinance and

statutory provisions, pertinent constitutional principles and factual information contained in the record. The County's hearing procedures, adopted per Idaho Code §67-6534, require that final decisions be in the form of written findings, conclusions, and orders. CCCO 07-05-03(1)(I).

The application, CR2023-0005, was presented at a public hearing before the Canyon County Board of County Commissioners on June 11, 2025. Having considered all the written and documentary evidence, the record, the staff report, oral testimony, and other evidence provided, including the conditions of approval and project plans, the Board of County Commissioners decides as follows:

CONDITIONAL REZONE CRITERIA - CCCO §07-06-07(6)

1. Is the proposed conditional rezone generally consistent with the comprehensive plan?

Conclusion: The proposed conditional rezone change is <u>not</u> generally consistent with the Comprehensive Plan.

- Findings: (1) The 2030 Canyon County Comprehensive Plan designates the parcel and area as "residential" (Exhibit 3.B.2c). The residential designation is described as follows: "The residential designation is for residential development. Residential development should promote compatibility with the existing agricultural activity" (page 25, 2030 Comp. Plan).
 - (2) The parcel and surrounding area are located in the Nampa Area of City Impact. Nampa designates the future land use of the parcel and area as "Low-Density Residential" (Exhibit 3.B.2d). However, at the time the applicant applied, Nampa's 2040 Comprehensive Plan designated the area as commercial (Exhibit 3.A.2).
 - (3) On March 6, 2025, the Planning and Zoning Commission recommended denial of the request due to the request not being generally consistent with the 2030 Canyon County Comprehensive Plan (Exhibits 1 and 2). The Board of County Commissioners concurs and finds the requested commercial zone and uses do not align with the following goals and policies of the 2030 Comprehensive Plan:
 - a. <u>Population G2.02.00</u>: "Promote housing, business, and service types needed to meet the demand of the future and existing population."
 - i. The Traffic Analysis Zone (TAZ) forecasts the area for residential household growth in the area between 2024 and 2050 (Exhibit 3.B.2h). The TAZ is used by COMPASS (Community Planning Association) as a tool to plan funding for future transportation needs.
 - b. <u>Economic Development G3.05.00</u>: "Support a diverse economy in Canyon County and recognize that residential, commercial, and industrial uses are necessary components of overall economic stability."
 - i. The County and City of Nampa both identify the area for residential growth, not commercial growth (Exhibits 3.B.2c & d).
 - c. <u>Land Use & Community Design P4.03.01</u>: Designate areas that may be appropriate for industrial, commercial, and residential land uses while protecting and conserving farmland and natural resources.
 - i. The County and City of Nampa both identify the area for residential growth, not commercial growth (Exhibits 3.B.2c & d).
 - d. <u>Land Use & Community Design P4.03.02</u>: Encourage the development of individual parcels and subdivisions that do not fragment existing land use patterns.
 - i. The County and City of Nampa both identify the area for residential growth, not commercial growth (Exhibits 3.B.2c & d).
 - e. Land Use & Community Design P4.04.02: Align planning efforts in areas of city impact.
 - i. The parcel and surrounding area are located in the Nampa Area of City Impact. Nampa designates the future land use of the parcel and area as "Low-Density Residential" (Exhibit 3.B.2d). The City of Nampa opposes the request (Exhibit 3.D.1).

- (4) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.
- (5) Evidence includes subsequent findings and evidence found in criteria 2 and 3.
- 2. When considering the surrounding land uses, is the proposed conditional rezone more appropriate than the current zoning designation?
 - **Conclusion:** In consideration of the surrounding land uses, the proposed conditional rezone to a "CR-C-1" (Conditional Rezone Neighborhood Commercial) is <u>not</u> more appropriate than the current zoning designation of "R-R" (Rural Residential).
 - Findings: (1) Existing/Current Conditions
 - A. The parcel and surrounding area are zoned "R-R" (Rural Residential, two-acre average minimum lot size, Exhibit 3.B.2e). According to CCCO §07-10-25(2), "the purpose of the R-R (Rural Residential) Zone is to encourage and guide growth in areas where a rural lifestyle may be determined to be suitable." The zoning is commensurate with the 2030 Canyon County Comprehensive Plan, which designates the parcel and area as "residential" (Exhibit 3.B.2c).
 - B. The parcel and area are in the Nampa Area of City Impact. The city designates the future land use of the area as "low-density residential" (Exhibits 3.B.2d & 3.D.1). City jurisdiction is located approximately 2,000 feet west of the subject parcel (Exhibit 3.B.2d).
 - C. The area consists of parcels with an average lot size of 1.78 acres and a median of 1.05 acres. There are 46 residential subdivisions within a one-mile radius consisting of 844 lots and an average lot size of 1.38 acres (Exhibit 3.B.2g). 13 of the 46 subdivisions are located in the City of Nampa.
 - **D**. The following land use decisions were found in the vicinity between 2016 and 2024, demonstrating the support of residential growth in the area:
 - <u>PH2016-10 Parcel R30461</u>: Rezone from "R-R" to "R-1" (Single Family Residential, one-acre average minimum lot sizes, 12,000 square foot lot sizes if connected to city water/sewer).
 - (2) <u>RZ2022-0008 Parcel R30591</u>: Rezone from "A" to a "CR-R-1".
 - (3) <u>RZ2018-0027 Parcel R247916010</u>: Rezone from "R-R" to "R-1".
 - (4) <u>PH2018-64 Parcel R27925</u>: Rezone from "R-R" to "R-1".
 - (2) <u>Request</u>
 - A. The applicants request a "C-1" (Neighborhood Commercial) zone. Pursuant to CCCO §07-10-25(5), "the purpose of the C-1 (Neighborhood Commercial) Zone is to provide for local commercial service needs and to restrict incompatible uses."
 - B. There are no commercial zones or similar land use decisions within the vicinity of the subject parcel (Exhibit 3.B.2f). The applicant states the area has similar businesses within the vicinity (Exhibit 3.A.2). Businesses found within the immediate area (Nick's Custom Designs, Gem Swim, Holistic Alchemist Wellness and Bodywork, and Zeguro Tax and Accounting, Exhibit 3.B.6) are allowed in the "R-R" zone subject to meeting home business or home occupation requirements per CCCO Section 07-02-03, 07-10-27, and 07-14-11 & 13 (Exhibit 3.B.5). Based on the site visit (Exhibit 3.C), staff did not find any contractor shops/staging area uses in the immediate area.
 - C. The nearest commercial use and designation is the Nampa Gateway Center within Nampa city jurisdiction, approximately 2,500 feet west of the subject parcel. The City of Nampa opposes the request and requested uses due to the city's future land use designation

supporting low-density residential zones, and that the uses proposed are not supported in a low-density residential zone (Exhibit 3.D.1).

- D. On March 6, 2025, the Planning and Zoning Commission recommended denial of the request due to the requested zoned not being more appropriate than the current zoning designation of "R-R" (Exhibits 1 and 2). The Board of County Commissioners concurs.
- (5) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.

3. Is the proposed conditional rezone compatible with surrounding land uses?

- **Conclusion:** The proposed conditional rezone to "CR-C-1" (Conditional Rezone Neighborhood Commercial) is <u>not</u> compatible with surrounding land uses.
- **Findings:** (1) Pursuant to CCCO § 07-02-03: "Land uses are compatible if: a) they do not directly or indirectly interfere or conflict with or negatively impact one another and b) they do not exclude or diminish one another's use of public and private services."
 - A. The parcel and surrounding area are zoned "R-R" (Rural Residential, two-acre average minimum lot size, Exhibit 3.B.2e). The parcel and area are in the Nampa Area of City Impact. The city designates the future land use of the area as "low-density residential" (Exhibits 3.D.1 and 3.B.2d).
 - B. The area consists of parcels with an average lot size of 1.78 acres and a median of 1.05 acres. There are 46 residential subdivisions within a one-mile radius consisting of 844 lots and an average lot size of 1.38 acres (Exhibit 3.B.2g). 13 of the 46 subdivisions are located in the City of Nampa.
 - C. The following land use decisions were found in the vicinity between 2016 and 2024, demonstrating the support of residential growth in the area:
 - <u>PH2016-10 Parcel R30461</u>: Rezone from "R-R" to "R-1" (Single Family Residential, one-acre average minimum lot sizes, 12,000 square foot lot sizes if connected to city water/sewer).
 - <u>RZ2022-0008 Parcel R30591</u>: Rezone from "A" to a "CR-R-1".
 - <u>RZ2018-0027 Parcel R247916010</u>: Rezone from "R-R" to "R-1".
 - <u>PH2018-64 Parcel R27925</u>: Rezone from "R-R" to "R-1".
 - D. There are no commercial zones or similar land use decisions within the vicinity of the subject parcel except Nampa Gateway Center approximately 2,500 feet west of the parcel in Nampa city limits and some home business and home occupation uses that are allowed in an "R-R" Zone (Exhibits 3.B.2f & 3.B.6).
 - E. On March 6, 2025, the Planning and Zoning Commission recommended denial of the request due to the requested zoned not being compatible with surrounding land uses (Exhibits 1 and 2). The Board of County Commissioners concurs.
 - (2) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.

4. Will the proposed conditional rezone negatively affect the character of the area? What measures will be implemented to mitigate impacts?

Conclusion: The proposed conditional rezone will negatively affect the character of the area. However, the applicants propose conditions such as hours of operation and site-obscuring fencing to minimize the impacts on the surrounding residential uses.

- Findings: (1) The area consists predominantly of residential uses. Staging areas, contractor shops, and caretaker residences are prohibited in all residential zoning districts (Exhibit 3.B.5). In the "A" (Agricultural) zone, the next closest designation (Exhibit 3.B.2e), the requested uses require a conditional use permit due to the uses possessing "characteristics which require review and appraisal by the commission to determine whether or not the use would cause any damage, hazard, nuisance or other detriments to persons or property in the vicinity" (CCCO §07-07-01: Conditional Use Permit Purpose).
 - (2) There are no commercial zones or similar approved uses within the vicinity of the subject parcel (Exhibit 3.B.2).
 - (3) The applicants propose conditions such as hours of operation and site-obscuring fencing to minimize the impacts on the surrounding residential uses. The letter of intent (Exhibit 3.A.2) states the property is used for their business, CBI Insulation, which includes the parking of six box trucks and employee parking for nine employees (Exhibit 3.A.4). The parking area is enclosed by vinyl fencing. Business hours are approximately 7 am to 5 pm (box truck parking 5 pm to 7 am). The existing detached garage has a restroom that may be for employees.
 - (4) Notice of the public hearing was provided per CCCO §07-05-01. Affected agencies were notified on May 7, 2025. A newspaper notice was published on May 12, 2025. Property owners within 1,000' were notified by mail on May 7, 2025. The property was posted on May 7, 2025.
 - a. No public comments.
 - b. A comment was received from the City of Nampa's Planning and Zoning Division on October 9, 2024 (Exhibit 3.D.1). The city opposes the request due to the proposed commercial zone and requested uses not being compatible with the Low-Density Residential designation.
 - (5) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.
- 5. Will adequate facilities and services, including sewer, water, drainage, irrigation, and utilities be provided to accommodate the proposed conditional rezone?
 - **Conclusion:** The project will have adequate sewer, water, drainage, irrigation, and utilities to accommodate the proposed conditional rezone.
 - Findings: (1) Sewer: The existing dwelling is served by a septic system. The staging area/contractor shop uses requested as part of the conditional rezone application do not require a new septic system (Exhibit 3.A.4). The existing garage restroom may be used for employees (Exhibit 3.A.2). Southwest District Health requests the applicant meet regarding the request (Exhibit 3.D.4). No information was submitted demonstrating a meeting was completed.
 - (2) <u>Water</u>: The existing dwelling is served by a domestic well. The staging area/contractor shop uses requested as part of the conditional rezone application do not require a new well. The existing well can be used for fire suppression (Exhibit 3.A.4).
 - (3) <u>Drainage</u>: It appears that drainage is maintained on-site (Exhibit 3.B.2a and 3.C). Nampa-Meridian Irrigation District requests that all drainage be maintained on-site (Exhibit 3.D.2).
 - (4) <u>Irrigation</u>: The applicant does not say if they have irrigation water rights or if the property is irrigated by a well. The letter from the Nampa-Meridian Irrigation District does not indicate if the property has water rights from the district (Exhibit 3.D.2). The property only has approximately 0.26 acres of grass/tree areas. The rest of the property is gravel (Exhibit 3.B.2a). Therefore, the property could be irrigated by a domestic well per Idaho Code Section 42-111.
 - (5) <u>Utility</u>: The property appears to have utilities established for the existing dwelling (Exhibit 3.C).

- (6) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.
- 6. Does the proposed conditional rezone require public street improvements in order to provide adequate access to and from the subject property to minimize undue interference with existing or future traffic patterns? What measures have been taken to mitigate traffic impacts?

Conclusion: The request is not anticipated to create undue interference with existing or future traffic patterns.

- **Findings:** (1) The subject property has access to Stamm Lane, a rural local roadway. Nampa Highway District #1 does not state any concerns regarding the request and future traffic subject to meeting access requirements (Exhibit 3.D.6).
 - (2) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.
- 7. Does legal access to the subject property for the conditional rezone exist or will it exist at the time of development?

Conclusion: The subject property does have legal access to the existing residential development.

- Findings: (1) The subject property has access to Stamm Lane, a rural local roadway. Nampa Highway District #1 requires commercial accesses to have a paved apron installed per ACCHD Standard Drawing #ACCHD-106. The applicants will need to upgrade the existing residential access to a paved apron to meet Highway District Commercial Access standards (Exhibit 3.D.6).
 - (2) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.
- 8. Will the proposed conditional rezone amendment impact essential public services and facilities, such as schools, police, fire, and emergency medical services? What measures will be implemented to mitigate impacts?
 - **Conclusion:** The proposed uses are not anticipated to impact essential public services and facilities, including, but not limited to schools, police, fire, and emergency medical services.
 - **Findings:** (1) Schools: The property is served by the Nampa School District (Exhibit 3.B.1). The request with limited uses is not anticipated to impact the school district. No comment was received from the district.
 - (2) Police: The property is served by the Canyon County Sheriff's Office. No comment or concerns were received from the Sherriff's Office.
 - (3) Fire Protection & Emergency Medical Services: The property is served by Nampa Fire District and Canyon County Paramedics/EMT. No comments or concerns were received from Canyon County Paramedics/EMT. Nampa Fire District is not opposed to the request (Exhibit 3.D.5). The request does not negatively impact response time. The property is 1.6 miles from Nampa Fire Station 5 with a response time of approximately four minutes.
 - (4) Evidence includes the application, supporting materials submitted by the applicant, public testimony, and the staff report with exhibits found in Case No. CR2023-0005.

Conclusion: The property is located within the Nampa Area of City Impact. A notice was sent to the City of Nampa per Canyon County Code of Ordinances (CCCO) §09-11-25 (09-11-17(3)).

Findings: (1) The City of Nampa was noticed on October 9, 2024, January 29, 2025, and May 7, 2025. A comment was received from the City of Nampa's Planning and Zoning Division on October 9, 2024 (Exhibit 3.D.1).
