# AN ORDINANCE REPEALING ORDINANCE NO. 17-003 DESIGNATING A COUNTY GUN RANGE BOARD AS AN ADVISORY BODY AND PROVIDING AN EFFECTIVE DATE

**WHEREAS**, there has been a Canyon County Gun Range Advisory Board ("Advisory Board") in existence for eight (8) years signed on March 13, 2017; and

WHEREAS, the Advisory Board's recommendations have resulted in the creation of long-range plan for the George W. Nourse Gun Range ("Range") and many substantial improvements to the Range; and

WHEREAS, the adoption of a long-range plan and the creation of Canyon County Sheriff's Training area adjacent to the existing Range have created redundancies in the missions of the Advisory Board and roles of other County officials; and

WHEREAS, the Board of County Commissioners believe the County is now best served with the Sheriff and County Parks, Cultural, and Natural Resources Department ("Parks") working collaboratively on the management of the Range with solicitation of expert and citizen input on the development of the area made directly by the Sheriff and Parks when needed.

**NOW THEREFORE IT IS ORDAINED**, by the Canyon County Board of County Commissioners as follows:

**Ordinance No. 17-00**3, the ordinance known and cited as Canyon County's Ordinance Designating a County Gun Range Board as an Advisory Body, Chapter 1, Article 21 is hereby repealed in its entirety.

**Ordinance No. 17-003** is repealed pursuant to the authority conferred by Idaho Constitution, Article 12, Section 2, and Idaho Code §§ 31-714, 31-801 and 31-828.

**Ordinance No. 17-003** shall be and is hereby declared to be in null and void upon publication as provided by law in one (1) issue of the Idaho Press-Tribune and as provided for in Idaho Code §§ 31-715 and 31-715A.
